- 1. Oil and Gas Extraction Point Source Category, Offshore Subcategory; Effluent Limitations Guidelines and New Source Performance Standards. OMB Number 2040-A281. The proposed rule was received by OMB on 12/24/90 and OMB review was completed on 2/28/91. The proposed rule has RIN number 2040-AA12. The proposed rule was published on March 13, 1991, at volume 56 of the Federal Register page 10664.
- 2. Criteria for Classification of Solid Waste Disposal and Practices;

Identification and Listing of Hazardous Waste; Requirements for Authorization of State Hazardous Waste Programs. OMB Number 2050-A539. The proposed rule was received by OMB on 3/20/95 and OMB review was completed on 5/15/95. The rule has RIN number 2050-AE11. The proposed rule was published on June 12, 1995, at volume 60 of the Federal Register page 30964.

- 3. Land Disposal Restrictions Phase III: Decharacterized Wastewaters, Carbamate and Organobromine Wastes, and Spent Potliners. OMB Number 2050-A533.
