This responds to your Freedom of Information Act (FOIA) requests dated 23 April, 3 May (2 letters), 10 June, 22 July, 4 August, 6 September, and 7 October 2004 in which you request the following:

- Copies of all photographs, videos, and any other media containing images of caskets holding
 the remains of US military personnel taken by DoD personnel or DoD contractors received at
 Dover Air Force Base since Mr. Russ Kick's December 2003 FOIA request, including but not
 limited to the materials already provided by our office to Mr. Kick in response to his FOIA
 request.
- All photographs of caskets containing the remains of US military personnel received at any US military facility between 7 October 2001 and the present.

The photographs, which are responsive to your 23 April 2004 request, are being provided on a CD.

To protect the privacy interests of the families and individuals involved and to minimize the possibility that release may rekindle grief, anguish, pain, embarrassment, or disrupt the peace of mind of surviving family members, we removed all personally identifying information of the remains or other individuals depicted in the photos. Due to recent events and increased risk to personnel, military and civilian, the Department of Defense has revised its policy and will no longer release names of personnel or other personally identifying information, e.g., name tags of personnel currently or recently assigned with a particular component, unit, organization or office within the Department of Defense. Release would jeopardize the safety of personnel assigned as well as constitute a clearly unwarranted invasion of personal privacy. Authority is the Freedom of Information Act, United States Code, Title 5, Section 552(b)(6).

You also requested identifying information that may accompany these images, such as research finding aids, indexes, captions, dates, logs, and records management materials. Responsive records consist of an e-mail from the 436 CS FOIA Manager dated 27 May 2004, which we have also attached. We have removed third party personal information from this e-mail (names). Our authority is Title 5, United States Code, Section 552(b)(6).

A thorough search of Air Mobility Command records has failed to locate any records responsive to your requests dated 3 May, 10 June, 4 August, 22 July, 6 September, and 7 October 2004.

If you desire to appeal our decision, please write to the Secretary of the Air Force, through HQ AMC/A63BR (FOIA), 203 W. Losey Street, Room 3600, Scott AFB IL 62225-5223, within 60 calendar days from the date of this letter. Include your reasons for reconsideration and attach a copy of this letter.
