MR. MOYERS: You have the bills which the President has signed.

You will soon have a statement by the President on the signing of S. 1160, the so-called Freedom of Information bill.

You have a statement by the President designating a Task Force to work on the problems of handicapped children and child development, and to recommend legislative proposals for the next Congress.

That is all I have.

Q Bill, there are four releases in all; is that right?

MR. MOYERS: There are five. You also have the Executive Order entitled "Prevention, Control and Abatement of Water Pollution by Federal Activities."

Q When did he sign the Freedom of Information bill?

MR. MOYERS: About five minutes ago.

Q Do you happen to have a summary of that bill and the bill on Federal employees' compensation?

MR. MOYERS: I do, but it is out at the ranch. It is on its way now by car. It will get here in an hour and a half or so. I don't get them until after he signs them. We do not get the summaries until after he signs them.

Q Will you post them?

MR. MOYERS: Yes, I will post it as soon as it gets here.

Q Bill, Governor Brown said the President explained to him why he wasn't going to the Governors' Conference, but Mr. Brown had forgotten the reason. I wonder you would by any chance know the reason?

MR. MOYERS: I wasn't a party to that conversation. The Governor telegraphed the President and urged him to come.

Then the Governor called the President and asked him to come.

The President said that he would be coming out there sometime, but that he couldn't come at this time.

Bill, I have seen some published reports that Mayor Yorty said that the President is not coming because he, Mayor Yorty, suggested that he not do so. Is there any truth to that?

MR. MOYERS: No.

Bill, the Communist Chinese say that the United States is planning to send ground forces into Laos. Have you any comment on that?

MR. MOYERS: No.

When did Governor Brown and the President have a telephone conversation?

MR. MOYERS: Some time ago, Bob. I don't have the exact date.

It was not this week?

MR. MOYERS: No.

Will the members of the group studying the handicapped be forthcoming later? That group has not been

MR. MOYERS: Secretary Gardner will name those people.

Will he do that today?

MR. MOYERS: No.

We have two major queries, one of which is: Is Luci at the ranch?

MR. MOYERS: Yes.

Also, we are asked if you can confirm a report from Canberra, Australia, that the President may visit Australia later this year or early next year to open a naval communications base in the western part of the country.

MR. MOYERS: I have no knowledge that he will be going. I cannot confirm that.

How is the President going to spend the Fourth of July, Bill?

MR. MOYERS: He will be around the ranch a good part of the day, I am sure. He was working at his desk when I talked to him just before I came down here. He has a good talked to him just before I came down here. He has a bit of paper work that came down in yesterday's pouch, including some of these bills. He plans to have lunch there, he said. Beyond that I simply don't know.
