



4. (U) UNTIL THE TIME OF HIS ARREST, ARMY MAJOR EDUARDO SANTOS VERGUERRA WAS SERVING AS DEPUTY COMMANDER OF THE 11TH BRIGADE'S 33RD INFANTRY BATTALION "JUNIN," HEADQUARTERED IN MONTERIA. THE THREE ARRESTED POLICE OFFICERS (ALBERTO BELTRAN ESTREMOR, JUAN CARLOS SILVA GELVES, AND OSCAR SOLANO PEDRAZA) HAD BEEN SERVING AS THE COMMANDERS OF POLICE STATIONS IN THE NORTHERN BOLIVAR TOWNS OF EL GUAMO, SAN JUAN NEPOMUCENO, AND SAN JACINTO RESPECTIVELY, ANOTHER AREA LONG CONSIDERED TO BE A CASTANO STRONGHOLD. 



7. (U) ON FEBRUARY 17, POLICE AND MARINES IN SAN ONOFRE, SUCRE DEPARTMENT, KILLED FOUR PARAMILITARIES IN COMBAT AND DETAINED TEN OTHERS. THEY ALSO SEIZED A GRENADE LAUNCHER, GUNS AND AMMUNITION, AS WELL AS DOCUMENTS INDICATING THE PARAMILITARIES BELONGED TO CASTANO'S ACCU. TWO POLICE WERE KILLED AND FOUR INJURED IN THE CLASH. IN SEPARATE INCIDENTS, FOUR CONVIVIR (RURAL SECURITY COOPERATIVE) MEMBERS WERE RECENTLY ARRESTED IN ANTIQUIA FOR ALLEGED INVOLVEMENT IN THE AUGUST 14 MASSACRE OF TEN LUMBERJACKS, WHILE THE HEAD OF A CONVIVIR IN ARAUCA DEPARTMENT IS ALSO UNDER ARREST IN CONNECTION WITH A SPATE OF VIOLENT DEATHS IN RECENT MONTHS.

(C) AFTER APPARENTLY RUNNING OUT OF AMMUNITION IN CONFRONTATIONS WITH THE GUERRILLAS, TWENTY-TWO PARAMILITARIES (VICE 23 AS ORIGINALLY REPORTED) SURRENDERED TO THE ARMY NEAR THE PANAMANIAN BORDER ON FEBRUARY 7 (REF B). THE 17TH BRIGADE, UNDER A NEW COMMANDER SINCE THE DEPARTURE OF GENERAL DEL RIO AT THE END OF THE YEAR, PUBLICLY HANDED THE PARAS OVER TO THE FISCALIA FOR INVESTIGATION. CONCLUDING COMMENT

9. (C) COMMENT: THIS CRACKDOWN COMES IN THE WAKE OF THE GOC'S PUBLIC INSISTENCE IN RECENT MONTHS THAT IT WAS SERIOUS ABOUT CRACKING DOWN ON PARAMILITARISM. NEVERTHELESS, THESE INCIDENTS ARE THE FIRST SUSTAINED, CONCRETE ACTION THAT WE CAN POINT TO CLEARLY PUTTING THIS POLICY INTO PRACTICE. TAKEN TOGETHER WITH THE ARREST OF VICTOR CARRANZA (REF C) AND THE MILITARY'S APPARENT NON-INVOLVEMENT IN OVERBLOWN CLAIMS OF PARAMILITARY MASSACRES IN PTO. ASIS (REF D), IT SUGGESTS THAT WE MAY BE CROSSING A WATERSHED ON THE NETTLESOME ISSUE OF THE MILITARY-PARAMILITARY NEXUS, AT LEAST IN PART OF THE COUNTRY.




