AUGUST HE PROVIDED LIAISON OFFICER (LO) A WRITTEN SUMMARY OF THE CASE. (EMBASSY HAS ALSO RECEIVED COPIES OF THIS SUMMARY.) GUERRERO ADDED THAT LO AGREED TO CONDUCT AN ANALYSIS OF THE SUMMARY AND MAKE SUGGESTIONS FOR FOLLOW-ON ACTION BY DOMINICAN POLICE.

2. GUERRERO ALSO STATED THAT LO OFFERED TO PROVIDE POLYGRAPH EQUIPMENT AND OPERATOR TO DOMINICAN POLICE IN ORDER TO CONDUCT POLYGRAPH EXAMS OF SEVERAL KEY PERSONS INVOLVED IN THE INVESTIGATION.
