SUBJECT: ITA: Mobile Unit Operation Changes The Embassy Film Section recently acquired a document drafted by the Iranian Department of Propaganda and now filed there pertaining to the USLE mobile unit operation in the provinces. The document was acquired through informal channels and has not as yet been brought to the attention of USIE in an official form. The changes and limitations proposed in this document have not been considered seriously by the Film Section and no counter action can be taken until the proposed changes are officially brought to the attention of the Film Section. CO (0) The document was prepared by Mr. Soltani, an official of the Department of Propaganda who oversees the operation of the mobile unit program for Mr. Bashir. Faramand, Director of the Department of Propaganda. The content of the document is being transmitted for the information of the Department and may indicate some of the difficulties of negotiation and compromise under which the Film Section must endeavor to carry out a mobile unit operation. The existing (7) arrangement was more fully described in Embassy Despatch 947. March 4, 1952, following extensive negotiations early last spring. The desire of certain Iranians to 'take over' the operation and eliminate American control and the constant search by the Film Section for a more satisfactory operation in terms of American interests has resulted in a situation that is never stationary and requires constant negotiation. Until the various restrictive clauses of this report are put into effect by the Tranian government no action will be taken. The tenor of this document does illustrate the type of Iranian thinking which is the basis of some of the difficulties in implementing an efficient USIE mobile unit program. In view of the extensive length of this report the Despatch author has arbitrarily assigned Roman numeral and alphabetical designations in the margin to the various portions of the report. These designations may be of assistance in future reference to the report. The most important portions in terms of restrictions on the scope of activities are the following: A. Introduction "Now that the first part of the educational programs, carried out through the roving film units, has come to an end and a new program is to begin, it was deemed necessary to bring to your attention points of interest from the past experience-achievements as well as short-comings.

"Apart from few trivial occasions, the program in general has given very good results and in some cases even more than it was expected. The supervisors have everywhere performed their programs with great success and the people have always welcomed them. By film-shows in the fields of education, agriculture, and sanitation they have enhanced their spectators' thinking level and have familiarized them with usage of equipment already at their disposal. Commending letters and requests received by our office prove the usefulness of the programs. I can assure you that, although the work done by these units is in its preliminary stage as yet, we have been able not only to attract the people but also help them in their grasp of new ideas. It gives me a great pleasure to say here that the Department of Press and Propaganda is proud of the work of some of its units.

Incidents

"In some places the inhabitants had never seen any movie picture and they first thought our projectionists were wizards but gradually they realized the meaning of their work and liked it. With this in view, it is understood that the people; movie as a novelty for them, were only charmed during the first one or two shows with little attention paid to the real subject. In order to get better results from our film-shows it is desirable that in each locality several shows be given one after another so that the people may have a chance to learn more.

"A remarkable warm welcome is being given to our units now that the people have learned more about the nature of their work. In very few places have they been confronted with opposition on the part of the people. In one or two places some opposition was first seen from a religious point of view but when our projectionists gave some explanations there was no more trouble.

"In some villages when the people saw some film-shows: on methods of disease prevention they told our supervisors; that they didn't have bread to eat how could they afford to have mosquito nets and some other necessary means. They said it would be far better had the government sent them some bread rather than undertake to spend so much money sending them films. In some places the inhabitants asked for doctor and medicine rather than films but when our projectionists explained to them that first they had to acquire some knowledge and learn how to deal with a sick person | and when they were told that the government had already the matter of doctor and medicine under consideration they looked to be satisfied. In some sections of the country where there is some labor force the workers asked for film-shows depicting labor life and its problems and I believe their request is a just one. It is necessary that a number of such films

be prepared (presenting the work and the life of the industrial labor, etc.) and he put at the disposal of those prejections of the actuation.

#### Recommendations

A. Feature Films "Another point which I would like to bring to your attention is the matter of some entertainment films which will have a moral value as well. I think, in addition to educational film-shows we must have some shows which will more or less be a pleasant pastime mixed with some moral lesson.

B. Far From American Scene "From report sent in by our supervisors, it has become evident that the people especially liked our film on the subject of why children die and how can we prevent dysentery and the reason for that is because the subject matter falls in their everyday life. In other words the more the films are connected with their lives and the farther they are from odd scenes of American and European large cities, the better the people will like and realize them.

C. Climatic

"From our past experience we have learned that it would be more desirable were the country divided into two regions namely winter region and summer region. This has become actually necessary because of the extremely divergent climatic conditions in various parts of the country which sometimes make the work impossible. For example it is virtually impossible to carry on film shows during the hot summer in Bandar Abbass and equally impossible to work at Ardabil or in its surroundings at winter time. Furthermore, the people can hardly be brought together. It is, therefore, advisable to send the units during hot weather to northern region and at wintertime to hot regions. In this manner operation can go on very easily throughout the country round the year.

D. Supervisors

"Contrary to the past practice, the unit supervisors must not be changed. Each supervisor must be appointed by a written order and as long as he discharges his duties in a satisfactory manner he must stay on his job. Supervisors are trained for their jobs and there is no reason to justify their change unless they are incompetent and not suitable for the work. It is suggested, therefore, that those who are suitable be picked up and be appointed by written orders (not temporarily) and as long as they do all right stay on the job. This will save us a lot of trouble in calling back the people and making new assignments. Some object to the per diem of the unit supervisors. I would say that that attitude is unfair. It is not an easy job to run a unit. To make speeches, to attract people, to deal with different classes and categories, to be able to take up some matters.

with government authorities - all these functions need men of quite high caliber. In addition to these, there are some hardships in the routine of the work which not everyone would telepase such as travel on rough roads month after menth, staying evernight at places where no food can be obtained not to say about insecurity. It is the intention of the government to give shows at such localities rather than in towns. Therefore, it is quite essential that we have such supervisors who would not only be well-qualified for the job but also be prepared to meet such difficulties rather than work for per diem.

E. Training

"Another matter which needs due consideration is the matter of training the supervisors which, by your permission, will have to be done after they are selected.

- To DDT Ministry of Education, our supervisors have reported that almost everywhere in the country the inhabitants are dissatisfied of the DDT spray work. They say, contrary to previous years, spraying now has no effect whatsoever: it causes a lot of trouble and the insects are not killed. In some cases those responsible for the spraying job are thought to be involved in some fraud. Should this situation continue, it is afraid the work will be confronted with severe opposition on the part of the people.

By experience we have learned that the people in remote areas are frightened of foreign propaganda and dislike it no matter whether it is American, Russian or British. A sort of suspicion arouses in their minds which is not desirable if good result is to be obtained from our work.

- "3. A film-strip be prepared on harmfulness of opium and alcohol.

- 14. As a response to the request of the workers it is suggested that a film be prepared on the living conditions of the workers and how they work in factories.

"11. It is up to the supervisor to appoint the place Select Show and locality of the film shows.

IV.

"The supervisors of the units should, in addition to the conditions which are mentioned in the Regulations, take into consideration the following points:

"1. Their behavior should be such that the Press; and Propaganda Department will feel proud of them. They must secure the goodwill of the people in every case.

"2. They must possess dignity and a good deal of personality and their conduct must be of such nature as to impress the people as well as government authorities and local dignitaries.

"3. They must possess ability to make speeches and enough knowledge to give correct and detailed explanation and be able to impress the people.

"l. They must be able to make their speeches reasonable and logical.

"5. They must have no immoral weak points.

"6. They must be able to realize the people and win their sympathy.

"7. They must possess a good deal of initiative and be able to know and realize aspirations of the people of each locality and arrange suitable film-shows.

"8. They should have enough self respect not to sacrifice their own dignity or that of the office for their selfish ends.

"9. They should not be drunkards, opium smokers or possess immoral reputation.

# "Duties of the Supervisors

## "A - Arrangement of Programs

- "l. Immediately after arrival at places where they intend to arrange film-shows they should inform the Tehran office of their mail or telegraphic address so that connections can be maintained.
- "2. In cases when they intend to go around and give shows at various places they should leave enough data regarding their whereabouts with some reliable persons through whom they can be reached without loss of time.
- "3. Immediately after arrival at the central town of an Ostan the supervisor whould get in touch with the local government authorities (army or civilian especially the governor, for whom he holds a letter of introduction, and



- "5. Proper care should be taken of the unit as far as tire, gas, etc. are concerned. Tours must be planned with great care to avoid useless waste of petroleum!
- "6. After each night's show the supervisor should make his report. He must not wait to make his reports after he is through with his 26-day program.
- "7. At the end of his 26-day show tour he will return to his Ostan headquarters; will reply to letters received; have his unit served and after a 4-day rest set out for another direction with the approval of the Ostan's governor.

### "B - Way Program Should Be Executed

- "1. Immediately after arrival at the place of his program the supervisor should get in touch with the local government agents and explain to them his plans and in cases when needed he should get the approval of religious leaders of the place with regard to his film-shows.
- "2. Before he begins with his film-show he must ask the governor the mayor or some local dignitary to give a brief talk in local dialect and explain to the people the educational value of the programs.
- "3. After that the supervisor should give a brief account about the film explaining its instructive importance in the fields of education, sanitation, etc. and in places where his audience are unable to understand him he should have a tape recorded in local dialect or language.
- "5. It is advisable that the supervisors invite the local officials dignitaries to their film-shows.
- "6. The supervisors must stress in their talks the government's and the Shah's goodwill and His Imperial Majesty's aspirations regarding the welfare of the people and should encourage them to unite in their support and by no means should they mention any party, religious or political questions.

- "2. Respecting government officials will naturally result in more help and cooperation from them since the local government officials are more familiar with prevailing conditions in their areas.
- "3. Supervisors should inform the Tehran office regarding those government officials who help and guide the units so that they may be recommended for their services.
- 114. Supervisors must take care not to involve themselves in internal matters of the local government agents.
  - "D How the supervisors should behave themselves among the people
- "1. The supervisors should keep in mind that the people look to them as their teachers, hence they must always behave themselves properly.
- "2. They must not mix in the domestic and private affairs of the people unless when some guidance is needed in health and educational matters.
- any cases or complaints to the supervisors, as government officials, they should not interfere directly or pass' judgment; they must rather mention the case to the government official agents indirectly and give them some friendly advice and let them decide what to do. Supervisors are requested to send their report in such cases to the Tehran office.

- "7. Generally speaking, it is advisable that the supervisor and the unit technician be friendly with each other.

"In the end it should be stressed that the supervisors must not maintain any contact with the Information office. They must send all their reports to the Press and Propaganda Department."

In forwarding this report to the Department, the Embassy wishes to emphasize the fact that this is an internal report, prepared by a major Iranian official for his chief. It is intended to serve as a guide to current official Iranian thoughts on the mobile unit operations. It is most unlikely that any attempt will be made to implement all of the recommendations. However, it is almost certain that attempts (in the nature of probes) will be made to secure our agreement to some portion of the suggested revisions.
