Major Fields

Students select their two major fields from the following list. Core courses in each field ensure that students meet the program's multi-country requirements with course work covering, at least, two countries. Students are encouraged to take courses on South and Southeast Asia in addition to courses on China, Korea, and Japan. With the approval of the <u>program director</u>, students may substitute courses on South or Southeast Asia for one of the core courses in each field.
