FOLLOWING IS TEXT STATEMENT AS DELIVERED IN SC THIS MORNING:

"MR. PRESIDENT,

"IN HER SPEECH YESTERDAY THE FOREIGN MINISTER OF ISRAEL DREW ATTENTION TO THE PHRASE "ADEQUATE REPARATION" AND INQUIRED AS TO ITS PRECISE MEANING. SHE MADE THE THOROUGHLY REASONABLE CONTEN-TION THAT IF THE COUNCIL WAS TO ACCEPT THE PHRASE "ADEQUATE REPARATION" THE COUNCIL SHOULD KNOW BEFOREHAND WHAT "ADEQUATE REPARATION" WAS INTENDED TO MEAN.

"ACCORDINGLY THE UNITED STATES NOW WISHES TO STATE ITS VIEW OF WHAT THIS PHRASE MEANS.

"THE UNITED STATES CONSIDERS THAT "ADEQUATE REPARATION" WILL HAVE BEEN MADE BY THE EXPRESSION OF VIEWS BY THE SECURITY COUNCIL IN THE PENDING RESOLUTION TAKEN TOGETHER WITH THE STATEMENT OF THE FOREIGN MINISTER OF ISRAEL MAKING APOLOGY ON BEHALF OF THE GOVERNMENT OF ISRAEL WE THEREFORE THINK THAT WHEN WE HAVE ADOPTED THE RESOLUTION, "ADEQUATE REPARATION" WILL HAVE BEEN
