SUBJECT: SYSTEMATIC DEBRIEFING OF NICARAGUAN REFUGEES

1. CONFIDENTIAL - ENTIRE TEXT.

2. WITE THE CONTINUED REFUGEE EXODUS FROM NICARAGUA, EMBASSY BELIEVES THERE IS A UNIQUE OPPORTUNITY TO GATHER INFORMATION ON CONDITIONS INSIDE OF NICARAGUA FOR INTELLIGENCE AND ESPECIALLY PUBLIC AFFAIRS PURPOSES. AT THE MCMENT, THIS EMBASSY CARRIES OUT REFUGEE INTERVIEWS ON AN AD HOC BASIS, AS TIME PERMITS BY EMBASSY POLITICAL/REFUGEE OFFICER, WHO HAS SUBSTANTIAL OTHER REPORTING AND CPERATIONAL RESPONSIBILITIES AS WELL. SOMETHING MORE SYSTEMATIC SEEMS TO BE CALLED FOR.

3. WHEN HE WAS LAST HERE, CTTO REICH AND I DISCUSSED THE POSSIBILITY OF SOMEONE FROM S/LPD OR HA COMING FOR A MCNTH CR TWO TDY TO DO REFUGEE INTERVIEWS TO HELP ESTABLISH A BASELINE OF INFORMATION FOR US. THE OFFICER COULD JUST AS APPROPRIATELY COME FROM ARA, INR OR RP. AT THIS STAGE, I WOULD LIKE TO ASK THE DEPARTMENT TO CONSIDER THIS ISSUE ON A PRICRITY BASIS AND ADVISE ME AS TO ITS THOUGHTS AS TO HOW WE MIGHT BEST APPROACH THE MATTER OF SYSTEMATICALLY INTERVIEWING NICARAGUAN REFUGEES, AT LEAST ON A TDY BASIS.
