SUBJECT: SECURITY ASSURANCES TO HONDURAS

- THIS IS AN ACTION MESSAGE.
- SUMMARY: AMBASSADOR WAS SUMMONED TO HONDURAN NSC MEETING MAY 15 TO DISCUSS SECURITY ASSURANCES. GOH. ACCEPTS OUR LANGUAGE BUT PRESIDENT, FOREIGN MINISTER AND CHIEF OF ARMED FORCES ARE ADAMANT THAT THEY BE SIGNED BY PRESIDENT'S SUAZO AND REAGAN AT THEIR MAY 21 GOH ARGUMENT RESTS ON THE FACT THAT THEY DROPPED THEIR INSISTENCE ON A SEPARATE BILATERAL SECURITY PACT AND THEREFORE BELIEVE A SIGNED COMMUNIQUE IS NEEDED TO MEET MINIMUM EXPECTATIONS OF HONDURAN PUBLIC OPINION. AMBASSADOR AFTER REVIEWING OUR ARGU-MENTS AGAINST THIS PROPOSAL. PROMISED TO TRANSIT THIS RENEWED GOH REQUEST TO WASHINGTON FOR REPLY. WASHINGTON'S RESPONSE TO PRESIDENT SUAZO'S REQUEST. END SUMMARY.
- I WAS SUMMONED TO A HONDURAN NATIONAL SECURITY COUNCIL MEETING MORNING MAY 15 TO DISCUSS THE ISSUE

OF SECURITY ASSURANCES. PRESIDENT SUAZO WAS PRESIDING AND HIS TOP CIVILIAN AND MILITARY ADVISORS WERE IN ATTENDANCE. THEY HAD OBVIOUSLY BEEN MEETING FOR SOME TIME. PAZ BARNICA SPOKE FIRST. HE EXPLAÍNED THAT GOH FORMED LANGUAGE OF OUR SECURITY ASSURANCES TO BE SATISFACTORY BUT THAT GOH WAS DISTURBED BY DAS MCNAMARA'S EXPLANATIONS DAY BEFORE TO EFFECT THAT A SIGNED DOCUMENT WOULD NOT RPT NOT BE POSSIBLE. SAID GOH HAD DROPPED-ITS EARLIER INSISTANCE ON A SIGNED BILATERAL SECURITY PACT BECAUSE THEY UNDERSTOOD THE PROBLEMS IT GAVE US; BUT IN ITS STEAD THEY HAD EXPECTED WHATEVER ASSURANCES WE MIGHT BE PREPARED TO GIVE TO BE IN THE FORM OF A SIGNED JOINT COMMUNIQUE ("DECLARACION CONJUNTA"). PAZ THEREFORE ASKED THAT I CONVEY TO WASHINGTON ONCE AGAIN STRONG GOH DESIRE THAT ASSURANCES BE JOINTLY SIGNED.

- 5. AT MY SUGGESTION, ARMED FORCES CHIEF OF STAFF, COLONEL GONZALEZ THEN REVIEWED THE POINTS MADE BY DAS MCNAMARA AT THE MAY 14 MEETING ON THIS SUBJECT AND I TOOK THE OPPORTUNITY TO REPEAT THAT SIGNING THESE ASSURANCES SEEMED TO GIVE WASHINGTON A SERIOUS PROBLEM.
- 6. PRESIDENT SUAZO THEN INTERJECTED THAT GOH INSISTENCE IS NOT BASED ON LACK OF CONFIDENCE IN THE USG'S WORD OR IN THE VALIDITY OF THESE ASSURANCES. ON THE OTHER HAND BOTH GOH AND THE HONDURAN PEOPLE WOULD HAVE GREAT DIFFICULTY IN UNDERSTANDING WHY THESE ASSURANCES WERE BEING ENSHRINED IN "JUST ANOTHER PRESS COMMUNIQUE". HE FELT THIS COULD CAUSE A NEGATIVE REACTION IN HONDURAS. SUAZO ASKED THEREFORE THAT, ON HIS OWN BEHALF AND BEHALF OF ENTIRE NSC, USG RECONSIDER ITS POSITION ON THIS ISSUE. I PROMISED TO TRANSMIT GOH REQUEST ASAP.

THERE ARE TWO WAYS TO SOLVE THIS CURRENT IMPASSE, IF WASHINGTON IS WILLING TO GIVE GROUND ON THE POINT OF "SIGNING". THE FIRST IS TO ACQUIESCE IN THE SUAZO REQUEST SINCE HE FEELS STRONGLY THAT HE NEEDS SUCH A SIGNED ASSURANCE FOR DOMESTIC POLITICAL PURPOSES. - THE OTHER OPTION IS TO GO AHEAD WITH THE JOINT STATEMENT AS CURRENTLY DRAFTED AND PRO--MISE THE HONDURANS A LETTER FROM THE PRESIDENT WHICH WOULD BE SENT IMMEDIATELY FOLLOWING THE VISIT AND WHICH WOULD REPEAT THE ESSENTIAL POINTS OF THE SECURITY THIS WOULD ENABLE US TO KEEP THE JOINT ASSURANCES. STATEMENT AS LOW-KEY AS POSSIBLE AND SHOULD INDUCE THE HONDURANS TO COOPERATE IN ANY REMARKS TO THE PRESS DURING THE VISIT. SEVERAL DAYS THEREAFTER, BUT WELL OUT OF WASHINGTON, THEY WOULD HAVE SIGNED CONFIRANTION. SINCE THE LETTER WOULD CONTAIN NOTHING NOT ALREADY IN THE STATEMENT, THERE SHOULD BE NO DIFFICULTY IN SENDING SUCH A LETTER. I WOULD APPRECIATE WASHINGTON'S RESPONSE TO PRESIDENT SUAZO'S REQUEST SOONEST. NEGROPONTE
