


#### A. GENERAL CONSIDERATIONS


- (1) THE HUMAN RIGHTS ISSUE TODAY IS, ALONG WITH NARCOTICS TRAFFICKING AND ENVIRONMENTAL ISSUES, A KEY POINT ON THE INTERNATIONAL AGENDA. THE EXECUTION OF A HUMAN RIGHTS DEFENSE POLICY IN COLOMBIA HAS BECOME A CONDITION FOR ACCESS TO NEW MARKETS, INVESTMENT OPPORTUNITIES AND STRATEGIC MATERIALS.
- (2) THE GOVERNMENT OF COLOMBIA IS AWARE THAT OUR HUMAN

- (3) THE PRESIDENTIAL POLICY FOR THE PROMOTION, PROTECTION AND DEFENSE, OF HUMAN RIGHTS IS A STATE POLICY. EFFORTS MADE BY FORMER ADMINISTRATION ON THIS ISSUE ARE ADDRESSED TODAY UNDER ONLY ONE DIRECTION THROUGH SEVERAL STATE AND GOVERNMENT AGENCIES COOPERATING IN A JOINT MANNER. THE EXECUTION OF THIS POLICY REPRESENTS AN ESSENTIAL ELEMENT IN ACHIEVING CIVILIZED COEXISTENCE IN THE QUEST FOR PEACE. THIS POLICY CONTRIBUTES TO STRENGTHENING JUSTICE AND COMBATTING IMPUNITY.
- (4) THE PROMOTION AND DEFENSE OF HUMAN RIGHTS TOUCHES ALL OF US: THE STATE AND THE SOCIETY. IT IS EXTREMELY IMPORTANT TO HAVE AN OPEN AND PERMANENT DIALOGUE ON THIS



BESIDES WIDENING THE CULTURAL HORIZONS OF THE MEMBERS OF THE MILITARY, LEARNING AND ENFORCING A RESPECT FOR HUMAN RIGHTS HAS A POSITIVE ASPECT ON THE DISCIPLINE AND PROFESSIONALISM INHERENT TO THE MILITARY.

- CREATING THE NECESSARY TOOLS AND MECHANISM TO MAKE (2) THE MILITARY CRIMINAL JUSTICE SYSTEM -- PARTICULARLY INSOFAR AS IT CONCERNS HUMAN RIGHTS VIOLATIONS -- AN EFFICIENT INSTRUMENT TO INVESTIGATE AND, IF NECESSARY, PUNISH EXEMPLARILY.
- RESOLVING SITUATIONS OF HUMAN RIGHTS VIOLATION IN WHICH MEMBERS OF THE PUBLIC FORCE MAY BE INVOLVED. INDIVIDUAL CASE OF VIOLATION OF FUNDAMENTAL LIBERTIES IS A SERIOUS CASE WHICH MUST BE INVESTIGATED AND PUNISHED.
- CONTRIBUTING TO STRENGTHENING THE LEGITIMACY AND (4) CREDIBILITY OF THE MILITARY FORCES BOTH AT NATIONAL AND INTERNATIONAL LEVELS CONCERNING HUMAN RIGHTS. THE STATE SHOULD ATTEMPT TO NOT ONLY RECOVER ITS MONOPOLY OVER ARMED FORCES, BUT TO GUARANTEE ITS LEGITIMATE ENFORCEMENT.





- A. THE OFFICE OF HUMAN RIGHTS AND POLITICAL AFFAIRS HAS BEEN ESTABLISHED. IT WILL BE UNDER THE SUPERVISION OF THE MINISTER'S OFFICE.
- B. AN ORDER HAS BEEN ISSUED TO ESTABLISH HUMAN RIGHTS OFFICES IN EVERY MILITARY AND POLICE UNIT. THESE OFFICES SHALL BE SUPERVISED BY THE OFFICES OF THE INSPECTOR GENERAL AND EACH SERVICE WHICH WILL PROVIDE ADDITIONAL TECHNICAL AND HUMAN RESOURCES.



- C. STRONG AND DETERMINED SUPPORT HAS BEEN GIVEN TO THE PROMOTION AND APPLICATION OF INTERNATIONAL HUMANITARIAN LAW TO WHICH COLOMBIA IS A PARTY. ESPECIALLY, STRONG SUPPORT HAS BEEN GIVEN TO COLOMBIA'S ADHERENCE TO THE PROTOCOL II WHICH IS AN ADDITION TO THE FOUR GENEVA CONVENTIONS.
- D. THE MINISTRY OF DEFENSE IS COMMITTED WITH THE REFORM OF THE MILITARY CRIMINAL JUSTICE SYSTEM TO ADAPT IT TO THE 1991 CONSTITUTION. ITS CONSOLIDATION WILL RESULT IN AN EFFICIENT INSTRUMENT TO INVESTIGATE AND PUNISH THOSE SERVICE-RELATED CRIMES COMMITTED BY PUBLIC FORCES WHEN ON ACTIVE DUTY.








COMMISSION IS TO PRESENT ITS RECOMMENDATIONS ON HUMAN RIGHTS ISSUES TO THE GOVERNMENT. THIS COMMISSION IS A PARTY TO THE PEACE AGREEMENTS MADE BY THE GOVERNMENT WITH THE "CORRIENTE DE RENOVATION SOCIALISTA" (A GUERRILLA GROUP WHICH RENOUNCED ARMED STRUGGLE IN 1994). 





4. AS WAS APPARENT FROM THE SHATTUCK-BOTERO MEETING OF OCTOBER 6, THE MOD CLEARLY WANTS THE USG TO BE CERTAIN OF WHERE HE STANDS ON THE ISSUE OF HUMAN RIGHTS AND THE

ARMED FORCES IN COLOMBIA. THIS EXHAUSTIVE RECITATION OF
HIS ESTABLISHMENT OF A HUMAN RIGHTS OFFICE WITHIN THE
MINISTRY AND ITS AMBITIOUS SCOPE OF WORK REFLECT WHAT WE
CONSIDER TO BE A SINCERE EFFORT ON BOTERO'S PART TO DEAL
WITH A MILITARY INSITUTION THAT HAS TRADITIONALLY
STONEWALLED ON THE HUMAN RIGHTS ISSUE. FROM BOTERO'S AND
THE ADMINISTRATION'S POINT OF VIEW, THE LETTER IS ALSO
LIKELY TO SERVE AS A POINT OF REFERENCE IN THE GOC'S
EXPANDING DIALOGUE WITH HUMAN RIGHTS NGO'S.

IN THE PAST, THE GOC, LIKE THE USG, HAS COME UNDER INTENSE CRITICISM FOR ITS CLOSE MILITARY ASSITANCE RELATIONSHIP IN THE COUNTERNARCOTICS FIELD WITH THE UNITED STATES. OFTEN IT IS ALLEGED BY NGO CRITICS THAT US-PROVIDED ANTI-NARCOTICS ASSISTANCE IS PURPOSEFULLY DIVERTED TO COUNTERINSURGENCY EFFORTS BY THE COLOMBIAN ARMED FORCES. MORE RECENTLY, THE MOD HAS BECOME EMBROILED IN THE NARCO-FOMENTED "HUMAN RIGHTS" AND ENVIRONMENTAL PROTESTS CONCERNING COCA ERADICATION SPRAYING CONDUCTED WITH USG ASSISTANCE. WHILE WE AND THE GOC WOULD REFUTE EMPHATICALLY BOTH CHARGES, BOTERO WILL WANT TO BE ABLE TO POINT TO LETTERS AND MEETINGS WITH THE USG ON HUMAN RIGHTS AS A MEANS OF DEMONSTRATING HIS AND THE ADMINISTRATION'S ENGAGEMENT ON THIS ISSUE.








