I. FOLLOWING ARE FACTS ON SATELLITE INTERFERENCE. ON FIVE EPARATE OCCASIONS, BEGINNING 18 OCTOBER, A DEFENSE SUPPORT ROGRAM SATELLITE (FOR INFRARED DETECTION) WAS ILLUMINATED FOR ERIODS OF OVER FOUR HOURS. MAGNITUDE OF SIGNAL PROBABLY RULES OUT NATURAL PHENOMENA SUCH AS FOREST OR GAS WELL FIRES. NOTHING ESE UNUSUAL WAS NOTED ON THESE DATES. SPECULATION BY DIA IS THAT THE SOURCE MAY BE A LASER. ONE PROBLEM IS THAT GROUND LOCATION IN USER OF SIGNALS DOES NOT COINCIDE WITH ANY KNOWN LASER RED RELITY, AND THEREFORE MOBILE LASER MIGHT BE INVOLVED. CIA ELIEVES AT LEAST TWO SOURCES INVOLVED AND CIA REPORTS THAT ONE SOURCE IS NOT A LASER. THUS THERE IS NO AGREED JUDGMENT ON THIS. THE PROGRAM MANAGERS RULE OUT ANY SYSTEM MALFUNCTION AS AN EXPLANATION AND, IN ADDITION, TWO DIFFERENT OTHER SATELLITES IN ELLIPTICAL ORBIT PICKED UP AN INFRARED SIGNAL ON 17 AND 18 OVEMBER. (WE HAVE JUST BEEN ADVISED THAT CIA AND DIA RE REEVALUATING THESE EARLIER REPORTS. THE NEW ASSESSMENT WILL REACH YOU SEPARATELY IN TODAY'S PDB.)

2. THERE WAS NO DEGRADATION OF SATELLITE. I WOULD BE WARY ON THIS ONE, BECAUSE I RECALL ONE PREVIOUS REPORT, SAY A YEAR GO, IN WHICH A SIMILIAR EVENT PROVED TO BE A FLUKE OF SOME KIND. BUT, IN ANY CASE, I WOULD NOT DISMISS INCIDENT ON GROUNDS THAT SATELLITE IS ONLY EARLY WARNING, BECAUSE TWO OTHER SATELLITES MAY HAVE BEEN INVOLVED, AND DSP SATELLITE IS NOT ONLY EARLY WARNING, BUT IS OF CONSIDERABLE VALUE IN MISSILE TESTS, ETC.

3. ON RELATED SUBJECT, I HAVE TOLD EAGLEBURGER OF PIKE OMMITTEE PRESSURE TO DECLASSIFY INTERNAL CIA MEMOS ON HOLD NEMS THAT HAK SAW WHILE ON HIS TRIP. THEY CONTAIN MISLEADING NFO AND TITILLATING PHRASES ABOUT HAK HOLDING UP INFORMATION AND NOT LETTING CIA MAKE JUDGMENTS. I HAVE TOLD AGENCY THAT AT A MINIMUM THEY OWE IT TO PEOPLE INVOLVED AT LOW LEVELS SUCH AS FORMER NSC STAFFERS NOT TO INCLUDE THEIR NAMES IN HEARSAY

©SSIPY INTERNAL MEMOS. OTHERWISE THERE ARE NO GROUNDS FOR NSC D HOLD THEM OUT. MOREOVER, SANITIZED SCHLESINGER TESTIMONY GIVEN TO JACKSON WILL COME OUT ON SUNDAY; IT IS NOT BAD, AND EVEN HELPFUL IN SOME INSTANCES. IN ADDITION, WE WILL INFORM ACKSON OF RELEASE OF SANITIZED COLBY TESTIMONY WHICH INCLUDES HIS STATEMENT QUESTIONING SOVIET GOOD FAITH, BUT NOT CHARGING MY VIOLATIONS, AND INDICATING DIFFICULTIES IN AMBIGUITY OF ACTIVITY, ETC. ZUMWALT CONTINUES ON RAMPAGE CALLING FOR HAK TO E FIRED, BUT I SUSPECT HE IS IN PROCESS OF DISCREDITING HIMSELF.

4. ON MBFR, I HAVE ASKED JOHN LEHMAN TO CONTACT A FEW KEY CONGRESSMEN TO INFORM THEM THAT NATO HAS AGREED TO A NEW POSITION, AND HE ALSO GAVE A SHORT BACKGROUNDER TO THREE REPORTERS TO MEPARE THEM FOR NEWS; THEY WERE FAIRLY UNINTERESTED AND IGNORANT. MEANWHILE, I THINK YOU ARE FALLING BEHIND STORIES, IF YOU WAIT DO DO BACKGROUNDER UNTIL MONDAY; MARDER AND GETLER HAVE AREADY COVERED IT IN THIS MORNING'S POST, AND I SUSPECT THAT YOU WILL ADD TO THE STORY ON THE WAY TO LONDON. BUT IN ANY CASE, I REALLY CAN'T DO A BACKGROUNDER ON TUESDAY. NUCH BETTER THAT IT COME FROM STATE OR ACDA, BUT I WILL TRY TO BRIEF ONE OR TWO PEOPLE ON MY OWN. (MOST KNOWLEDGEABLE REPORTERS ARE WITH YOU.) I HAVE SENT MESSAGE TO RESOR, AND WILL SEND YOU SOME TALKING POINTS ON MONDAY.

MEANWHILE, WE HAVE A LITTLE PROBLEM WITH SOVIETS WHO HAVE MEMINDED EAGLEBURGER OF HAK'S PROMISE TO GROMYKO TO HAVE A DISCUSSION BEFORE WE MAKE OUR PROPOSAL. I WILL SEE VORONTSOV, BIT ABOUT ALL I COULD DO WOULD BE TO GIVE HIM OUTLINE AND EXPHASIZE THIS IS A SERIOUS MOVE OBTAINED AFTER GREAT PULLING AND HAULING, AND REQUIRES SERIOUS SOVIET. STUDY AND REPLY. ADVISE IF YOU HAVE ANY SPECIAL POINTS.
