

STATION HUST STRESS THAT HAS SIMPLY SAID THAT HE KNOWS SHE WAS KIDNAPPED, BUT HAS NOT . PROVIDED ANY SPECIFIC INFORMATION SUBSOUNDING THE KIDNAPPING. IN VIEW OF THE EXTREME SENSITIVITY OF THIS CASE, THIS IS A CRUCIAL POINT. AS HOS MAY BE AWARE, THE CASE HAS RECEIVED EXTENSIVE NEWS COVERAGE IN THE U.S., INCLUDING A STORY ON THE 20/20 NEWS SHOW. IN THE OPINION OF SHE WAS PROBABLY NOT PAPED OF OTREPWISE MISTREATED AS SHE CLAIMED, HOWEVER. SAID THAT WOMEN ARE NOT NORMALLY SEXUALLY HOLESTED AND IF THERE HAD BEEN ANY PHYSICAL MISTREATHENT BY HER CAPTORS SHE WOULD. HAVE BEEN KILLED RATHER THAN BELEASED. . THOSE RELEASED UNRARMED ARE SOMETIMES DRUGGED AND THEN RELEASED. WHEN THEY COME TO THEY ARE DISORGENTED AND OFTEN UNABLE TO GIVE AN ACCOUNT OF WHAT HAPPENED TO THEM. THIS MAY WELL HAVE BEEN THE CASE WITH ORTIZ. ADDED THAT OPTIZ WAS IN CONTACT WITH CEFTIST GUEPPICLAS, WHICH LED TO HEP APPEST. THE KILLING. STATION SUSPECTS THAT VARGAS TURNED DOWN AN RECRUITMENT PITCH OR IGNORED A DEMAND THAT HE CEASE OPERATIONS IN GUATEMACA CITY.

D. MYRNA [(MACK)] CHANG: PEPORTS THAT THE SERVICE ASSASSINATED THE POLICE OFFICER ASSIGNED TO INVESTIGATE A NUMBER OF HUMAN RIGETS CASES, INCLUDING THE HUPDER OF HYRNA [[KACX]] CHANG, A HEMBER OF THE GUATEMALAN GUERRILLA POLITICAL STRUCTURE. ALTHOUGH DID NOT SAY THAT THE SERVICE KILLED MACK, COMESS SAID THAT HE BELIEVES FROM THE NATURE OF THE KILLING AND THE ATTEMPTS TO SHIFT THE BLAME TO THE SERVICE (THE PRIME "SUSPECT", WHO CANNOT BE LOCATED, IS A FORMER CHARGE HERBER! THAT THE COMMENT SERVICE HAY WELL HAVE KILLED HER. TO BALANCE TRIS, TO PEPORTED THAT A CRIMINAL RILLED THE POLICE OFFICER BECAUSE OF A CORRUPTION CASE THE SLAIN POLICEMAN WAS INVOLVED IN. THE SERVICE PRODUCED A TAPE WHICH HAS A CONFESSION OF THE ALLEGED KILLER, A PETTY CRIMINAL. REPORTS THAT THE SERVICE INDUCED A CRIMINAL TO TAKE THE FALL FOR THE KILLING, WITH A PROMISE OF LATER RELEASE. THIS IS POSSIBLE, AND IT IS POSSIBLE THAT THE ACCUSED CRIMINAL OR OTHERS WERE ASKED TO CARRY OUT THE KILLING BY THE CONTROL SERVICE. IT IS ALSO POSSIBLE THAT THE WERE NOT INVOLVED ._ ALLEGED KILLING OF FIFTEEN CPININALS

INCLUDING A RADIO, WERE STOLEN FROM AN WALLES VEHICLE THAT
WAS ON A SURVEILLANCE MISSION IN GUATEMALA CITY.

PLACED ANOTHER CAR WITH "BAIT" IN THE SAME AREA SOME
TIME AFTER THE INCIDENT AND EVENTUALLY WERE ABLE TO CAPTURE IS
MEMBERS OF A CRIMINAL GANG OPERATING IN THE AREA. THEY HERE

2. IN ADDITION TO THE ABOVE, THERE ARE INDICATIONS OF HUMAN RIGHTS VIOLATIONS AGAINST HABITUAL CRIMINALS, MARCOTICS TRAFFICKERS AND TERRORISTS, BUT WE DO NOT HAVE ANY CLEAR INFORMATION ON OTHER CASES. IT SHOULD BE REHEMBERED THAT ALMOST ANY MURDER IN GUATEMALA IS LIKELY TO BE ATTRIBUTED TO THE SERVICE. IN FACT, THERE IS SO MUCH CRIMINAL ACTIVITY HERE (NOT TO HENTION POLITICAL ACTIVITY OF A VIOLENT NATURE) THAT IT IS USUALLY IMPOSSIBLE TO DETERHINE WHO IS REALLY PESPONSIBLE FOR ANY INDIVIDUAL ACT. AN EXCELLENT A GROUP LINICH INCLUS EXAMPLE OF THIS WOULD BE THE KILLING OF ELEVEN PERSONS BY THE A GUATEHALAN NAVY IF. THE NAVAL OFFICERS IN CHARGE HAD NOT CAPRIED OUT THE KILLINGS IN SUCE A CLUMSY PASHION, IT IS PROBABLE THAT NOBODY WODED HAVE EVER SUSPECTED THE HAVY OF CARRYING OUT THE RILLINGS. THEY HIGHT WELL HAVE BEEN FALSELY ATTRIBUTED TO CHECKET . IN ANOTHER INSTANCE, COME RAVE BEEN ACCUSED OF RAVING TRACKED DOWN THE GANG THAT PAPED AND ROBBED A GROUP OF GERMAN TOURISTS. IT HAS EVEN BEEN RUNORED THAT THEY RECEIVED DIRECT ORDERS FROM THE PRESIDENT OF GUATEMALA TO DO THIS. OF COURSE, THERE IS NO PROOF WHATSOEVER THAT THIS HAPPENED. TO FURTHER ILLUSTRATE THE POINT, THE KILLING OF FRANK VARCAS, THE SANDINISTA, HAS BEEN ATTRIBUTED TO THE SANDINISTAS, LOCAL CONTRA SUPPORTERS, LOCAL CRIMINALS (VARGAS WAS REPORTED TO BE INVOLVED IN DIRECT KINDS OF ILLEGAL ACTIVITY) AND, OF COURSE, CONTRACTOR OF THE COURSE, REGARDLESS OF THE STATEMENT, WE CANNOT RULE OUT THE POSSIBILITY THAT HE IS WRONG AND THAT THE THAT THE POSSIBILITY THAT HE IS WRONG AND THAT WAS MERELY BOASTING AND TAKING TOPPIT FOR A COINT O

ANOTHER PERSON. REGARDING THE SUPPORTING, "ATMOSPHERICS", AVE ALL NOW REPORTED ON A ATTERN OF HUMAN RIGHTS VIOLATIONS BY THE SERVICE AND THE GUATEMALAN ARMY IN GENERAL. THE EARLIER HENTIONED KILLING OF ELEVEN PERSONS BY A GUATEMALAN NAVY COMMANDER A FEW WEEKS AGO, A MATTER OF PUBLIC RECORD, IS NOW PUT INTO PERSPECTIVE. THE GENERAL OPINION EXPRESSED BY ALL OF THEM IS THAT THE EXTRAJUDICIAL KILLING OF CERTAIN CATEGORIES OF PERSONS IS ALMOST HOUTINE. IT IS APPARENTLY CONSIDERED JUSTIFIED TO KILL GUERRILLAS WHO REFUSE TO COOPERATE WITH THE ARMY, COMMON CRIMINALS AND MARCOTICS TRAFFICKERS. REPORTS OF THIS KIND ARE ONE THING, EOWEVER. PROOF OR SOLID EVIDENCE IS ANOTHER.
