FOR PRESIDENT ERNESTO SAMPER IN 1994, CAME TO RECENT PUBLIC ATTENTION ON JUNE 6, 1995. A NEWSPAPER ARTICLE MENTIONED THAT PLAZAS, WHO HAD BEEN NAMED COLOMBIAN CONSUL TO HAMBURG, GERMANY, HAD BEEN REJECTED BY THE GERMAN GOVERNMENT FOR HUMAN RIGHTS VIOLATIONS. [

ALLEGATIONS OF HUMAN RIGHTS VIOLATIONS CONTAINED IN THE BOOK, "STATE TERRORISM IN COLOMBIA," WRITTEN BY THE DUTCH-BASED HUMAN RIGHTS NGO "PAX CHRISTI." THE COLOMBIAN GOVERNMENT THEN TRIED TO ASSIGN PLAZAS AS CONSUL TO SAN FRANCISCO. [

DEPARTMENT CONCURRED THAT THE GOC BE INFORMALLY ASKED TO WITHDRAW PLAZAS' NOMINATION, [

4. (U) THERE ARE FOUR BASIC ALLEGATIONS OF HUMAN RIGHTS VIOLATIONS AGAINST PLAZAS THAT HAVE BEEN PUBLISHED:

- PLAZAS WAS A CENTRAL FIGURE IN ORGANIZING THE PARAMILITARY GROUP "DEATH TO KIDNAPPERS" (MAS) IN COLOMBIA'S EASTERN PLAINS IN 1981-82 (NOTE: ACCORDING TO AMERICAS WATCH, MAS WAS FORMED IN COOPERATION WITH THE OCHOA BROTHERS OF THE MEDELLIN CARTEL TO FIGHT GUERRILLA KIDNAPPERS. END NOTE).
- IN 1985, ACCORDING TO A RETIRED OFFICER AND EX-PARAMILITARY MEMBER, PLAZAS CREATED AND DIRECTED A PARAMILITARY GROUP IN CUNDINAMARCA (PROVINCE WHERE BOGOTA IS LOCATED) SPONSORED BY MEDELLIN CARTEL KINGPIN GONZALO RODRIGUEZ GACHA.
- IN NOVEMBER 1985, AS PART OF THE COMMAND THAT STORMED THE JUSTICE PALACE WHERE M-19 GUERRILLAS HELD OVER 100 PERSONS HOSTAGE, PLAZAS WAS HEARD ORDERING THE "DISAPPEARANCE" OF M-19 MEMBER IRMA FRANCO PINEDA, ONE OF THE WOMEN ALLOWED TO LEAVE THE BUILDING BEFORE THE FINAL ASSAULT. ANOTHER HUMAN RIGHTS BOOK, "EL CAMINO DE LA NIEBLA I," SUGGESTS THAT PLAZAS ALSO ORDERED THE "DISAPPEARANCE" OF GLORIA ANZOLA, A CIVILIAN LAWYER WHO HAPPENED TO BE IN THE BUILDING.
- ON AUGUST 15, 1986, PLAZAS ORDERED THE ARREST OF ALVARO FALLA IN BOGOTA. ACCORDING TO THE MILITARY, FALLA JUMPED OUT OF A MOVING MILITARY VEHICLE IN AN ATTEMPT TO ESCAPE AND DROWNED IN THE BOGOTA RIVER.

5. (C) NONE OF THE ABOVE ALLEGATIONS WERE EVER INVESTIGATED BY THE AUTHORITIES -- A COMMON PROBLEM DURING THE 1980'S IN COLOMBIA - - AND THERE IS NO WAY TO VERIFY THE TRUTH OF ANY OF THEM. PLAZAS VEHEMENTLY DENIES THE CHARGES, SAYING THEY ARE CONSPIRACY TO SLANDER HIM BY FORMER M-19 GUERRILLAS WHO NEVER FORGAVE HIM FOR HIS ROLE IN THE STORMING OF THE JUSTICE PALACE (REF C). PLAZAS SAID HE WOULD FILE A CIVIL COMPLAINT FOR SLANDER AGAINST THE AUTHORS OF "STATE TERRORISM."
