(CANGRORE) SUMMARY: DESPITE THE ASSIGNMENT OF THE SIX JUNTA ADVISERS TO PERMANENT POSITIONS WITHIN THE ARMED FORCES, THE JUNTA ADVISER GROUP APPARENTLY CONTINUES TO FUNCTION FOR THE TIME BEING; HOWEVER, ONLY TWO (2) OF THE SIX ADVISERS APPEAR TO BE ACTIVELY ENVOLVED, AND BG JOSE EFRAIN ((RIOS)) WONTT STILL PLANS TO EVENTUALLY TERMENATE THEIR PARTECIPATION IN JUNTA AFFAIRS. ONE OF THE SIX-MAN ADVISER GROUP, FIRST CAPTION CARLOS RODOLFO ((MINOZ)) PILONA, HAS SUPPOSEDLY ALIENATED SENTOR AND

JUNIOR OFFICERS ALTRE BECAUSE OF HIS PERCEIVED SUPERIOR ATTITUDE AND OFFERS OF FAVORABLE ASSIGNMENTS. WE IS ALSO ALLEGED TO HAVE ACCEPTED MONEY FOR HIS BOLE IN THE COUP OF 23 MARCH. DISSATIS-FACTION VITH GENERAL ORDER MARKER 10 CONTINUES; HOVEVER, THE CON-PLAINTS ARE MINIMAL AND APPEAR TO EMMATE ALMOST ENTERELY FROM A GROUP OF OFFICERS WHO BELONG TO THE SAME MILITARY ACADEMY PROM-OTION CLASS (MINRER 72). THREE OFFICERS FROM THIS PROMOTEON GROUP WERE ORDERED ARRESTED BY BG RICK FOLLOWING REPORTS THAT THEY WERE INVOLVED IN COUNTERCOUP PLOTTING AND HAD BEEN GUELTY OF CORRUPT ACTS DURING PRESIDENT FERNANDO ROMEO ((LUCAS)) GARCIA'S TEMBRE, FINALLY, SOME OFFICERS (NFI) REMAIN CONCERNED THAT 96 RIOS CONTINUES TO INTERJECT TOO MUCH OF HIS RELIGIOUS PIETY INTO EVERY DAY GOVERNMENT AFFAIRS. AS A RESULT, SOME OFFICERS BELIEVE HE SHOULD BE DUSTED.

ENCLUDED IN THE TRANSFER ONDER WERE THREE OF THE SIX MEMBERS OF THE JUNIA ROWISORY GROUP: COL VICTOR MANUEL ((ARGUETA)) VILLATUTA, REASSIGN-ED AS CHIEF, PRESIDENTIAL STAFF; WAJ ANGEL ARTURO ((SAMCHEZ)) GUDIEL, AIDA, PRESIDENTIAL STAFF; FIRST CAPTAIN CARLOS BUDOLFO (CHUMOZ)) PILOMA, S-3 OFFICER, PRESIDENTIAL STAFF. THE REMAIN-ING THREE JUNTA ADVISERS, LTC MARIO RENE (CENRIQUEZ)) MORALES. 20 CPT MARIO AUGUSTO ((RIYAS)) GARCIA, AMD ZLT MECTOR MAURICIO ((LOPEZ)) DOWELLA REASSUMED THE POSITIONS THEY HELD ON 23 MARCH (THESE WERE 20 BN CDG, MARISCAL ZAVALA BOE; COMBAT PILLT, BAF; PLT COR, TACTICAL SECURITY GROUP OF THE AIR FORCE, RESPECTIVELY). ALLEGEDLY, THE TRANSFERSYASSIGMENTS WERE DESIGNED (1) TO ENIT-TALLY CURTAIL THE ROLE OF THE ADVISER GROUP DN DAY-TO-DAY GOV-ERIMENT OPERATIONS, AND (2) PROVIDE THE BASIS FOR EVENTUALLY TERMINATING THE TITLE AND POSITION OF "JUNTA ADVISER". THE DECISION TO DININISH AND EVENTUALLY END THE ROLE OF THE SIX-MAN GROUP FOLLOWED SEVERAL HEATED DEBATES BETWEEN MEMBERS OF THE GROUP AND THE JUNTA BURING POLICY MEETINGS IN THE INITIAL WEEK

FOLLOWING THE COUP.

WAS DECIDED (1) TO TRANSFER/ASIGN EACH ADVISER TO A POSITION WETHIN THE CAPITAL, AND (2) THAT THE ASSIGNMENTS SHOULD BE OF SUFFICIENT IMPORTANCE AND COMMENSURATE WITH EACH OFFICER'S RANK. SUBSECUENT TO THE TRANSFERS/ASSIGNMENTS, BG KID WOULD DEVELOP SPECIAL PROJECTS WHICH WOULD OCCUPY A 6000 DEAL OF EACH ADVIERS'S TIME, THEREBY KEEPING THE COLLECTIVE GROUP OUT OF HIS WAY. EVEN-TUMLLY HE WOULD CUT OFF THE GROUP'S PARTICIPATION ENTERELY; HOWEVER; THIS LAST STEP WOULD HAVE TO BE ACCOMPLISHED WITHOUT OFFENDING ANY OF THE SIX-MAN GROUP. THREE OF THE MOVIERS WERE THEN TRANSFERRED UNDER MOD GENERAL ORDER MANBER 10, QHILLE THE REMAINING THREE ASSUMED THEIR PRE-23 NAT POSITIONS. BOTH LST CPT MEMOZ AND 20 CFT RIYAS HAVE MANAGED TO CONTINUE INVOLVENG THEM-SELVES IN THE AFFAIRS OF COVERNMENT (NFI). BOTH OFFICERS ALLEG-EOLY DEVOTE HALF OF THEIR DAY TO THEIR MILITARY BILLETS AND THE OTHER HALF TO NATTERS WHICH THEY BELIEVE CONE UNDER THE PURYLEY OF THE ADVISER GROUP (WFI). DESPITE BG RIDS' CONTINUED DISSATISFACTION WITH THE STATUS QUO AND HIS UNCERSING DESIRE TO TERMINATE THE INTERFERENCE ENTIRELY, HE DOES NOT WANT TO ACT TOO QUICKLY SO AS TO ALIENATE THE LATTER TWO OFFICERS.

ADDITIONALLY, SEVERAL JUNIOR OFFICERS WHO HAD PREVIOUSLY SERVED WITH CAPTAIN NUMBER, HAVE CIRCULATES STORIES OF RECEIVING INVITATIONS FROM THE CAPTAIN TO VISIT WITH HIM IN HIS OFFICE AT THE MATIONAL PALACE. THERE THEY ALLEGEDLY RECEIVED OFFERS OF FAVORABLE REASSIGNMENTS AND RIS ASSURANCES THAT HE (MUMOZ) COULD HELP THEN BESOLVE ANY FUTURE PROBLEMS THEY MIGHT HAVE

THIS PROMOTION CLASS, WHICH ORIGINALLY CONSISTED OF 95 OFFECERS, IS CONSIDERED AN AMONALY WITHIN THE ARMED FORCES BECAUSE OF THE EXCEPTIONAL CHEHESIVENESS IT HAS MAINTAINED THROUGHOUT THE YEARS, WILLE IT IS NOT EMUSUAL FOR THE OFFICERS OF A PRONOTION CLASS TO MAINTAIN SOME FRATERIAL TIES THROUGHOUT THEIR ACTIVE DUTY CAREERS, PROMOTION CLASS NUMBER 73 HAS ALLEGEDLY MAINTAINED A NUCH STRONGER RELATIONSHEP ANONG ITS CLASS NIMBERS. SUPPOSEDLY, THE CLASS MAINTAINES IT OWN STRUCTURAL ORGANIZATION, HAYING DIV-IDED ITSELF INTO GROUPS WITH GROUP LEADERS AND A CLASS PRESIDENT. THESE POSITIONS BOTATE ANONS THE CLASS MEMBERS PERIODICALLY. THE GROUPINGS FACILITATE THE PASSING OF INFORMATION AND ENHANCES THE COMMUNICATION LINK WITH ALL CLASS MEMBERS. PERIODICALLY, THERE ARE REETINGS OF THE GROUP LEADERS AND CLASS PRESIDENT TO PLAN

CLASS REUNIONS/FUNCTIONS AND TO PASS INFORMATION ON THE ACTIVITIES OF INDIVIDUAL CLASS MEMBERS (E.G. TRANSFERS, MARRIAGES, BIRTHS, DEATHS, PROBLEM, ECT.), FOLLOWING THESE MEETINGS EACH GROUP LEADER RELAYS THE ENFORMATION TO THOSE CLASS MEMBERS IN HIS GROUP.
FREQUENTLY THERE ARE CLASS FAMILY PICKICS, DANCES, OUTINGS, BIRTH-DAY CELEBRATIONS, ETC., WHEREIN ALL CLASS MEMBERS ARE REUNITED. ADDITIONALLY, THE CLASS MAINTAINS A MONEYARY KITTY ( WHICH ALL OFF-ICERS SUPPOSEDLY CONTRIBUTE TO FREELY) FOR EMERGENCIES OR HARD-SHIPS WHICH MAY BEFALL A CLASS MEMBER OR HIS FAMILY, FOR IN-STANCE, IF AN OFFICER FROM THE CLASS IS PLACED IN A "BAJA" STATUS (DROPPED FROM ACTIVE DUTY), THE CLASS NEWBERSHIP MAINTAINS THE OFFICERS PAY FOR A PERICO OF THREE MONTHS. THIS IS NOT A LOAM BUT A FREE GIFT TO ALLEYIATE ANY FAMILY SUFFERING UNTIL THE DEF-ICER CAN FIND ANOTHER JOE. NO OTHER PROMOTION CLASS SUPPOSEDLY PROVIDES SUCH A SERVICE. THERE ARE ALSO ATTEMPTS BY THE CLASS MEMBERS TO ASSIST EACH OTHER IN CETAINING MILITARY POSITIONS THAT WILL BE BENEFICIAL TO THE INDEVIOUAL'S CAREER. CLASS HEN-BERS WITH SERIOR MILITARY "PADRINOS" (GODFATHERS) IN POSITIONS OF AUTHORITY ARE ENCOURAGED TO USE THEIR INFLUENCE WITH THEIR SPONSORS TO HELP MNOTHER CLAS KENSER GET THE RIGHT JOB AT THE RIGHT TIME. THIS UNCORNER UNITY DIRECTLY CONTRIBUTED TO THE KANY COMPLAINTS AGAINST MOD GENERAL ORDER MUNBER 10 BY THE OFFICERS OF THE PROMOTION CLASS. SUPPOSEDLY, A MUMBER (NFI) OF THE OFFICERS FROM THIS CLASS AND ENJOYED CONFORTABLE JOBS IN THE CAPITAL DURING THE LUCAS ADMINISTRATION, NOW UNDER GENERAL ORDER MAMBER 10. MANY (MFI) WERE BEING TRANSFERRED TO NON-CONSEQUENTIAL JOBS, CR. MORST YET, TO OPERATIONAL AREAS WHERE THE LIVING IS FAR FROM PLUSH. MEMBERS OF CLASS 73, THEREFORE, BANNED TOGETHER TO TRY TO CHANGE GENERAL ORDER MANBER 10 THROUGH THREATS OF MASS RESIGNATIONS AMB/OR OPEN DEFIANCE OF THE ORDER, THIS NESSAGE WAS SUPPOSEDLY PASSED DIRECTLY TO BE RICE BY NEWBERS OF THE CLASS; HOWEVER, THEIR THREAT DID WOT IN MAY WAY INFLUENCE BE Alos TO RESCIND OR CHANGE THE ORDER. INSTEAD, 96 RIDS ONDERED THAT INVESTIGATIONS BE CARRIED OUT ON CERTAIN NEWBERS OF THE CLASS WHO HAD HELD POS-ITIONS IN THE PRESIDENTIAL GUARD AND STAFF, WHILE THIS PROCE WAS BEING CARRIED OUT. RUNORS BEGAN TO CIRCULATE THAT MEMBERS OF THE PROMOTION CLASS, WITH THE ALD OF THE MOVIMIENTO DE LIBERACTION (MLN) POLITICAL PARTY, NESE PLANNING A COUNTERCOUP AGAINST BG RIOS. COMCONITANTLY, THE CURSORY INVESTIGATION ORDERED BY BG RIOS ALLEGEDLY UNCOVERED INFORMATION WHICH INDICATED THAT AT LEAST THREE OF THE CLASS NEWBERS WAY HAVE BEEN GUILTY OF CORRUPT ACTS WHILE ASSIGNED TO THE PRESIDENTIAL GUARD AND STAFF DURING THE LUCAS YEARS, ALLEGEDLY, THREE OF THE OFFICERS FROM THIS PROMOTION CLASS, CAPTIONS MARIO S. ((LOPEZ))) SERRAND, MOBERTO E. ((LETONA)) HORA AND GITO F. ((PEREZ)) MOLIRA, HAD EACH IN-WESTED 100,000 QUETZALES/DOLLARS IN A PRIMATE ENTERPRISE (NEI).

OTHER MEMBERS OF PROMOTION CLAS 73 WERE ALSO BELIEVED TO BE INVOLVED BUT WITH INVESTMENTS OF LESSER MOUNTS, WHEN THE FIND-INGS OF THE INVESTIGATION AND RUMORS OF THE COUNTERCOUP REACHED THE EARS OF BG RIOS, HE ORDERED THAT THE THREE CAPTAINS (LOFEZ, LETONA AND PEREZ) BE ARRESTED AND CONFINED. THE OFFICERS WERE SUPPOSEDLY PICKED UP AT THEIR HOMES THE SAME EVENING AND TAKEN TO THE HOMOS GRIGADE. THIS ACTION BY 68 RICK WAS TO DEMONSTRATE TO THE REST OF THE PRONOTION CLASS THAT BG RIOS WAS AWARE OF THEIR ACTIVITIES AND WAS PREPARED TO TAKE ACTION AGAINST THEM. ON THE DAY FOLLOWING THE ARRESTS, BG RIOS CONFERRED WITH THE OTHER JUNTA NEMBERS AND HIS SIX-MAN ADVISER GROUP AND PRESENTED THE EVIDENCE AGAINST THE THREE OFFICERS, SINCE MOST OF THE EVID-ENCE WAS LARGELY CIRCUMSTANTIAL AND SINCE BE RIOS BELLEYED HIS POINT HAD BEEN HAD WITH THE OTHER OFFICERS OF CLASS MARBER 73. IT WAS DECIDED TO FREE THE THREE OFFICERS PENDING COMPLETION OF THE INVESTIGATION OF THEIR PERSONAL FINANCES; HOWEVER, BEFORE THE THREE CAPTAINS WERE ALLOWED TO RETURN TO DUTY, BE RIOS ALLEG-EDLY THELD A PRIVATE TALK WITH THEM. 13 DID NOT STOP ENTIRELY, EVERY OFFICER FROM THE CLASS THAT WAS REASSIGNED DID REPORT TO HIS NEW DUTY POST AS REQUERED. SINCE THEN THE OFFICERS OF PROMOTION CLASS 73 HAVE BEEN LESS VOCIFEROUS IN STATING THEIR DESPLEASURE WITH THE STATUS QUO. NEVERTHELESS, DISQUIETUDE CONTINUES, BUT THE CLASS STILL REMAINS AS UNIFIED AS

WHAT ESPECIALLY WORRES THESE OFF-ICERS IS THE IMAGE THAT MAY BE FORKING IN THE NIMOS OF FOREIGN DEPLOMATS STATIONED IN GUATEMALA. THEY BELIVE BE RIOS" MORAL-ISTIC APPROACH MAY IN THE LONG RUN HARM GUATEMALA'S CHANCES TO RECEIVE OUTSIDE ASSISTANCE. THERE HAVE ALSO BEEN COMPLAINTS ABOUT BG RIGS' CONTINUING HORAL CRITIQUES AT COMMANDERS' MEETINGS. HE HAS ALLEGEDLY FORBIDDEN OFFECERS TO SMOKE AND/ OR DRINK (AL-COHOL) AT THESE GET-TOGETHERS, AND, ON MORE THAN ONE OCCASION, HAS LECTURED THESE OFFICERS ON THE EVILS OF MOMANIZING. SOME OF THE COMMANDERS HAVE OPERLY STATED THAT BE RICS IS BEGINNING TO EXCEED HIS AUTHORITY BY STEPPING ON PERSONAL LIBERTIES. ALL THESE FACTORS HAVE RESULTED IN SOME OFFICERS (SENIOR AND JUNIOR) ADVOCATING THAT NG RIOS BE DUSTED FROM OFFICE. ADDITIONALLY, THESE SAME OFFICERS DO NOT BELIEVE THAT REPLACING BE RIOS WOULD CREATE EXTERNAL OR INTERNAL PROBLEMS AS LONG AS THE REFORMS AND PRIN-CIPLES ALREADY SET FORTH MOULD BE CARRIED ON (1), E. ELIMINATION OR CORRUPTION, CIVIC ACTION PROGRAMS, NEWABILITATION OF THE ECONOMY, ETC.), BG REGS' CRETICS WITHIN THE ARMED FORCES DO NOT BELIEVE HE HAS OVERWHELMING CIVILIAN MOPULAR SUPPORT EITHER. THEY SELIEVE THE SUPPORT IS FOR THE MILITARY AND WHAT IT DID ON 23 HARON. THEREFORE, SINCE THE MILETARY PUT RIOS IN OFFICE THEY CAN TAK HIM OUT.


