- (C) PAKISTAN ISI DIRECTOR LIEUTENANT GENERAL MAMOUD AND THE DEPUTY SECRETARY SPOKE BY TELEPHONE FOR 5 MINUTES ON 18 SEPTEMBER AT 1120.
- (C) GENERAL MAMOUD EXPLAINED THAT HE IS STAYING IN VERY CLOSE CONTACT WITH US AMBASSADOR CHAMBERLIN, BUT HADN'T HAD THE OPPORTUNITY TO SPEAK WITH HER THE LAST TWO DAYS DUE TO HIS TRAVELS TO AFGHANISTAN.
- 3. (C) GENERAL MAMOUD STATED THAT WHILE IN AFGHANISTAN HE HAD THE OPPORTUNITY TO MEET WITH ISLAMIC LEADER MULLAH OMAR, AS WELL AS OTHER GOVERNMENT AND JUDICIARY MINISTRY OFFICIALS. GENERAL MAMOUD SAID HE WAS ABLE TO LAY OUT CLEARLY TO THE AFGHANS THE SUBSTANCE OF WHAT DEPUTY SECRETARY ARMITAGE AND GENERAL MAMOUD HAD DISCUSSED IN WASHINGTON THE PREVIOUS WEEK. THIS INCLUDED THE ""DEMANDS, EXPECTATIONS, AND CONSEQUENCES" ASSOCIATED WITH THE DECISIONS FACING THE AFGHANS. GENERAL MAMOUD NOTED THAT HE EXPLAINED TO HIS INTERLOCUTORS THAT THE WORLD IS UNITED

AGAINST TERRORISM." SINCE THE AFGHAN ISLAMIC LEADERS HAVE ALSO RENOUNCED TERRORISM, GENERAL MAMOUD CONVEYED THAT IT IS OF CRITICAL IMPORTANCE THAT THEY FOLLOW-UP WITH CONCRETE ACTIONS.

4. (C) GENERAL MAMOUD INFORMED DEPUTY SECRETARY ARMITAGE THAT HE EXPLAINED TO THE AFGHANS THAT THEY MUST MEET THREE CONDITIONS. ONE, THEY MUST HAND-OVER UBL TO THE

ASSOCIATES OF UBL. HE ADDED THAT SOME OF THOSE INDIVIDUALS HAVE ALREADY BEEN INDICTED. AND THREE, THEY MUST CLOSE ALL

- 5. (C) GENERAL MAMOUD STATED TO DEPUTY SECRETARY ARMITAGE THAT HE ALSO ADDED A FOURTH CONDITION ON HIS OWN. GENERAL MAMOUD ADVISED THE AFGHANS THAT THEY MUST OPEN TERRORIST TRAINING SITES FOR INSPECTION BY NEUTRAL INTERNATIONAL OBSERVERS FROM THE WEST, "INCLUDING EVEN THE UNITED STATES." DEPUTY SECRETARY ARMITAGE THANKED THE GENERAL FOR ADDING THIS FOURTH CONDITION.
- (C) WITH RESPECT TO THE RESPONSE HE RECEIVED FROM THE 6. AFGHANS, GENERAL MAMOUD SAID THE "RESPONSE WAS NOT NEGATIVE AFGHANS, GENERAL MAMOUD SAID THE "RESPONSE WAS NOT NEGATIVE ON ALL THESE POINTS".
