3. SUMMARY: ENDOFF HAS HAD SEVERAL MEETINGS WITH

[REDACTED]
ACCOUNT OF NORMAN'S DEATH CORRESPONDS WITH WHAT
WE KNOW ABOUT THE CASE AND THE GCC ATTEMPT TO
COVER UP THEIR INVOLVEMENT. [REDACTED] INSISTS THAT
HE IS IN VERY REAL DANGER FROM THE CNI (CHILEAN
INTELLIGENCE) AND IS NOW SEEKING EMBASSY
PROTECTION AND AID. HE HAS COMPARED HIS SITUATION
TO THAT OF FERNANDEZ LARIZO AND WANTS TO GO TO
THE U.S. FOR SAFETY. CLEARLY [REDACTED] COULD BE
PART OF A GCC PLOT TO COMPROMISE EMBASSY OFFICIALS,
ESPECIALLY IN THE WAKE OF THE FERNANDEZ DEFECTON.

ON THE OTHER HAND, HE COULD BE ON
THE LEVEL AND HAVE USEFUL INFORMATION ABOUT COLONEL
ESPIKOZA, ONE OF THOSE UNDER INVESTIGATION IN THE

EMBASSY WOULD LIKE TO EXPLORE FURTHER WHAT

[REDACTED] KNOWN, BUT IT WOULD BE HELPFUL FIRST PRA 1; FOIA B-1
TO HAVE AN INDICATION FROM WASHINGTON AS TO WHETHER
ANYTHING HE SAID IS TRUE, OR POTENTIALLY USEFUL IN
LETTERER CASE. END SUMMARY.

END SUMMARY:

THE EMBASSY IN LATE FEBRUARY WHEN HE CALLED AND
ASKED FOR AN APPOINTMENT WITH THE POLITICAL
SECTION. HE SUBSEQUENTLY MET WITH A POLITICAL
OFFICER ON MARCH 18, APRIL 20, AND APRIL 24.
IN MID-MARCH HE ALSO MET WITH THE COMINT GENERAL.
HE RELATED THE FOLLOWING STORY.

4. HE IS [REDACTED]

ACCORDING TO [REDACTED] NORMAN WAS
DETAINED ON SEPTEMBER 18 BY A UNIT STATIONED
AT THE MILITARY SCHOOL DURING A ROUTINE ACTION
AGAINST A HOME REPUTED TO HOUSE EXTREMISTS.
MATERIALS WERE FOUND AT THE HOME WHICH WERE
CONSIDERED "EXTREMIST" IN CONTENT. NORMAN WAS

INTERROGATED AT THE MILITARY SCHOOL AND THEN
TRANSFERRED TO THE NATIONAL STADIUM FOR FURTHER
QUESTIONING. HE WAS ORDERED SHOT AND KILLED
THE EVENING OF SEPTEMBER 19. ACCORDING TO

[REDACTED] THE AUTHORITIES AT THE STADIUM DID PRA 1; FOIA B-1
NOT KNOW THAT NORMAN WAS AN AMERICAN SINCE HIS
PAPERWORK ARRIVED AFTER HIS DEATH, AND HIS POOR
KNOWLEDGE OF SPANISH MADE IT DIFFICULT FOR HIM
TO UNDERSTAND AND ANSWER QUESTIONS. THEY ONLY
KNEW THAT HE WAS A FOREIGNER AND AN "EXTREMIST".
THE BODY WAS TAKEN FROM THE STADIUM AND LEFT AT
A LOCATION TO CREATE THE IDEA THAT HE HAD BEEN
KILLED IN A FIREFIGHT WITH THE MILITARY.
HOWEVER, IN THE CONFUSED DAYS FOLLOWING THE
COUP, AND AFTER IT WAS KNOWN THAT HE WAS AN
AMERICAN, THE MILITARY SOUGHT TO HIDE THE FACT
THAT HE WAS DEAD. [REDACTED] CONFIRMED THAT NORMAN
WAS REQUIRED TO CHANGE CLOTHES SHORTLY BEFORE
HE WAS EXECUTED. ACCORDING TO [REDACTED] PEDRO
ESPIKOZA WAS THE ONE AT THE STADIUM WHO APPROVED
THE KILLING OF NORMAN. HE ADDED THAT SEVERAL
HUNDRED WERE SHOT AT THE STADIUM BUT THAT MANY
MORE WERE KILLED IN VALPARAISO, WHERE THE BODIES
WERE DUMPED AT SEA.

IS TO COMPROMISE HIGH EMBASSY OFFICIALS AS REPORTED IN REFTEL. REPORTS OF SUCH AN ATTEMPT HAVE REACHED US AND THE GOC WRATH OVER THE DEFECTON OF FERNANDEZ LARIOS HAS PRESUMABLY ONLY WHETTED THE GOC DESIRE TO CATCH US IN THE ACT. THEREFORE, WE HAVE CONCLUDED THAT THERE IS A VERY REAL POSSIBILITY THAT [REDACTED] IS PRA 1; FO 19 A-1 ATTEMPTING TO LURE US INTO A MISTAKE, SUCH #1 GO 12958 3.46/463 A MEETING WITH THE AMBASSADOR OR A RECREATION OF THE FERNANDEZ LARIOS SCENARIO. WE HAVE NO DOUBT THAT HE IS WHO HE SAYS HE IS. HE HAS PROVIDED DOCUMENTARY PROOF OF THAT AND HIS INFORMATION ON THE NORMAN CASE AND HIS OWN PERSONAL HISTORY HAVE CHECKED OUT. OUR CURRENT CONCERN IS WHAT TO DO WITH HIM.

THE UPSHOT OF ALL THIS WAS THAT HE WANTED THE U.S. GOVERNMENT TO GET HIM TO THE U.S. AS SOON AS POSSIBLE. DURING THE ENSUING DISCUSSION, IT WAS APPARENT THAT WHAT HE HAD IN MIND WAS SOMETHING SIMILAR TO THE DEAL STRUCK WITH FERNANDEZ LARIOS -- A HOTEL ROOM AND A NEW LIFE. HE REJECTED THE SUGGESTION THAT THE TWO CASES WERE DISSIMILAR. WHILE NEVER ACTUALLY REQUESTING ASYLUM, HE ARGUED THAT

WE WERE THE ONLY EMBASSY IN SANTIAGO THAT DID NOT GRANT ASYLUM.

POST NEEDS TO KNOW IF THE DEPARTMENT CONSIDERS THE INFORMATION TO BE WORTHWHILE, NOT ONLY FOR ITS REVELATIONS ABOUT THE NORMAN CASE BUT ALSO FOR ITS CONNECTION TO INDIVIDUALS INVOLVED IN THE LETELLIER CASE. WE CAUTION THAT THE THREAT OF ENTRAPMENT STILL EXISTS. POST WOULD APPRECIATE DEPARTMENT VIEW ASAP AS TO THE USEFULNESS OF MAINTAINING CONTACT WITH [REDACTED]
