EMBASSY IS THEREFORE INSTRUCTED TO INFORM THAT BEFORE WE COULD CONSIDER THE POSSIBILITY OF HIS TRAVEL TO THE UNITED STATES, WE WOULD HAVE TO INTERVIEW HIM MORE THOROUGHLY. THIS CANNOT BE DONE IN PRAI; FOIA Q.1 CHILE.
