THE FATE OF BAKACA (U) SUBJ:

THREE EXTENSIVE INTERROGATIONS AT THE HANDS OF INTERROGATORS FROM THE MI DIVISION. THAT HE FREELY TALKED AND PROVIDED INFORMATION TO THE INTERROGATORS ABOUT THE ORPA, IT'S POLICIES, PAST ACTIVITIES AND ITS PERSONNEL, BUT CONSTANTLY PROVIDED FALSE INFORMATION REGARDING ARMS CACHES THAT HE REPORTEDLY HAD INFORMATION ON. THE D-2 WAS HIGHLY INTERESTED IN LOCATING ANY ALLEGED CACHES IN SAN MARCOS AND CONCENTRATED ON THESE ISSUES DURING THE INTERROGATIONS. ON TWO SEPARATE OCCASIONS. RELATED THE FOLLOWING REGARDING THE CAPTURE. SUBSEQUENT INTERROGATION AND FINALLY, THE ELININATION OF EFRAIN ((BAKACA)) VELASQUEZ WHILE HE WAS HELD AS A PRISONER IN MILITARY ZONE 18 DURING MARCH AND APRIL OF

(SANFARKACC) ACCORDING TO BAKACA RECEIVED A RELATIVELY NIMOR WOUND IN ONE ARM DURING A FIREFIGHT WITH THE GUATEMALAN ARRY OUTSIDE OF RETALHULEU IN MARCH 1992. HE WAS CAPTURED AS A RESULT, AND INITIALLY INTERROGATED THERE. DURING THIS INITIAL INTERROGATION, IT WAS DETERMINED THAT HE KNEY MORE ABOUT THE REVOLUTIONARY ORGANIZATION OF PEOPLE IN ARKS (ORPA) IN THE SAN MARCOS AREA THAN HE DID ABOUT GUERRILLA ACTIVITIES IN AND AROUND RETALHULEU. STATE THAT BANACA WAS ALIVE WHEN HE WAS LOADED ON THE HELICOPTER.

(2\10\10\10C) OPINED THAT BANACA WAS KILLED SHORTLY THEREAFTER

OBSERVED D-2 HELICOPTERS FLYING LIVE GUERRILLAS SEVERAL MILES OUT TO SEA WHERE THEY WERE THRONG OUT AND DISPOSED OF. STATED THAT THIS MAS DONE TO GET RID OF ANY EVIDENCE THAT THEY HAD HAD THE GUERRILLAS IN THEIR CUSTODY.

BELIEVED THAT THIS IS WHAT MAPPENED TO BANACA AND IS PROBABLY WHY THE ARMY TODAY-STATES THEY DO NOT KNOW WHERE BANACA IS OR WHAT HAPPENED TO HIM.

• 7. (3/18/706/06). CONTINUED THAT IT WOULD BE - FAR EASIER FOR THE ARRY TO STATE THAT HE DIED IN CAPTIVITY, EXCEPT FOR THE FACT THAT THEY CAMOUT PRODUCE A BODY. NOT BEING ABLE TO PRODUCE A BODY ONLY-WEAKENS THEIR STORY AND LEAVES ROOM FOR DOUBT. ON THE OTHER HAND, CONTINUED, IF THEY WERE TO STATE THAT HIS RODY WAS DUMPED SEVERAL MILES AT SEA, THIS WOULD RAISE A HUE AND CRY MONG HAMM RIGHTS-ADVOCATES AND-POSSIBLY CREATE MORE PROBLEMS FOR THE ARMY REGARDING TECHNIQUES USED DURING THE THIRTY-FOUR YEARS OF WAR. 
