- 2. (U) TABAR WAS BORN APRIL 11, 1945 IN SALCEDO, DR. HIS PARENTS WERE PART OF THE WEALTHY LEBANESE IMMIGRANT COMMUNITY IN THE DR. HE STUDIED ECONOMICS AT THE AUTONOMOUS UNIVERSITY OF SANTO DOMINGO (UASD), BUT NEVER GRADUATED. HIS FAMILY CONNECTIONS LANDED HIM A JOB WITH THE NATIONAL SUGAR COUNCIL AS DIRECTOR OF COOPERATIVES AT THE AGE OF 17. HE WAS A MEMBER OF THE SOCIAL CHRISTIAN PARTY FROM ABOUT THAT SAME TIME, AND LATER BECAME A PAID ACTIVIST. TABAR JOINED THE RULING PRSC WHEN THE CHRISTIAN SOCIALISTS MERGED WITH PRESIDENT BALAGUER'S REFORMIST PARTY IN THE EARLY 70S. TABAR WAS APPOINTED CUSTOMS DIRECTOR IN 1986, AND HELD THE POSITION UNTIL MAY 1994, WHEN HE WAS REPLACED BY ANISIA RISI DE MERCEDES, WHOM HE NOW REPLACES. TABAR IS MARRIED, WITH CHILDREN.
- 3. (C) EMBASSY OFFICIALS OVER THE LAST TEN YEARS HAVE FOUND TABAR TO BE VERY INTELLIGENT AND HARD-WORKING. HE RAN THE CUSTOMS OFFICE WITH A VERY PERSONAL TOUCH DURING HIS TENURE, MAKING ALL KEY AND MANY ROUTINE DECISIONS HIMSELF. TECHNICALLY, HE IS SUPPOSED TO REPORT TO THE FINANCE MINISTER, BUT IN PRACTICE THE CUSTOMS DIRECTOR REPORTS DIRECTLY TO PRESIDENT CONFIDENTIAL

- 4. (U) NUNEZ WAS BORN IN 1940 IN TAMBORIL, DR, AND ENTERED THE NATIONAL POLICE IN 1961 AS A CORPORAL, TRANSFERRING FROM THE ARMY. HE WORKED HIS WAY UP TO HIS CURRENT RANK OF MAJOR GENERAL. HE HAS AMPLE COMMAND EXPERIENCE AS POLICE COMMANDER OF VARIOUS REGIONS, AND AS DEPUTY COMMANDER OF THE NATIONAL POLICE. MOST RECENTLY HE HAS SERVED AS COMMANDER OF THE SOUTHERN REGION OF THE NATIONAL POLICE. HE IS MARRIED TO VIOLETA GARCIA DE NUNEZ, AND HAS TWO DAUGHTERS, VIOLETA AND JOSELIN MILAGROS.
