- 3. SUMMARY: AN ARMY OFFICER WHO ALLEGEDLY BELONGED TO AN ARMY INTELLIGENCE/NATIONAL INTELLIGENCE SERVICE (SIN) GROUP THAT CARRIED OUT THE NOV. 1991 BARRIOS ALTOS MASSACRE IS WILLING TO SPEAK OUT. AN INTERMEDIARY TOLD US THAT THE OFFICER, WHO CLAIMS HE DID NONE OF THE ACTUAL SHOOTING, WANTS U.S. HELP IN RESETTLING IN A THIRD COUNTRY, POSSIBLY AFTER TRAVELLING TO THE U.S. TO SPEAK BEFORE HUMAN RIGHTS GROUPS.

THE OFFICER CLAIMS HE CAN LINK MONTESINOS TO THE BARRIOS ALTOS KILLINGS. A USG ROLE IN ASSISTING THE OFFICER SPEAK OUT WOULD BECOME A MAJOR SORE POINT IN BILATERAL RELATIONS. IT WOULD, HOWEVER, CONTRIBUTE SIGNIFICANTLY TO OUR HUMAN, RIGHTS GOALS. POLCOUNS WILL HAVE OPPORTUNITY TO MEET DISCREETLY WITH THE OFFICER IN COMING DAYS. - COMMENT: THE PERSON REPRESENTING THE ARMY OFFICER IS WELL KNOWN TO US. HE OPPOSES THE GOP, BUT IS NOT LINKED TO COUP PLOTTERS TO OUR KNOWLEDGE. UNTIL WE MEET WITH THE ARMY OFFICER, WE CANNOT ASSESS HIS CREDIBILITY. THE ARMY OFFICER'S REPORTED KNOWLEDGE OF THE BARRIOS ALTOS CASE, HOWEVER, PARALLELS THAT OF AN ANONYMOUS ARMY OFFICER QUOTED IN A DEC. 1992 ARTICLE IN "SI" MAGAZINE (REF C), AND WHAT ANOTHER ARMY OFFICER (NOT IN THE GROUP) TOLD US IN DECEMBER (REF D). (THE GOP IS SUING "SI" MAGAZINE, CLAIMING IT INVENTED THE ALLEGED ARMY SOURCE; ONE EFFECT OF THE OFFICER'S SPEAKING OUT WOULD BE TO BOOST THE "SI" DEFENSE.) IT DOES NOT APPEAR THAT THE OFFICER HAS ANY PHYSICAL EVIDENCE TO BACK UP HIS CLAIMS.
- 9. THE OFFICER'S OPTIONS IN LEAVING PERU ARE LIMITED. COMPLICATING MATTERS GREATLY IS THE NEED TO PROTECT THE OFFICER'S IDENTITY AND HIS DESIRE TO TRAVEL. ACCORDINGLY, THE OFFICER AND THE PERSON REPRESENTING HIM HAVE SPOKEN ONLY TO A FEW PERUVIANS, AND TO NO OTHER FOREIGNERS.
- 10. ASYLUM IN A LATIN EMBASSY IS A POSSIBILITY, BUT IN A CASE LIKE THIS THE GOP COULD WELL REFUSE TO ISSUE THE SAFE CONDUCT PASS TO THE AIRPORT; THE RECEIVING EMBASSY CONCEIVABLY COULD THEN BACK DOWN AND EXPEL HIM. ANOTHER POSSIBILITY IS TO GO TO THE UNHCR; THE PROBLEM

IS STUDIED. THE OTHER POSSIBILITY APPEARS TO BE THAT OF GOING TO THE U.S. FOR A SHORT PERIOD, TO SPEAK WITH HUMAN RIGHTS GROUPS, PRIOR TO RESETTLING IN A THIRD COUNTRY. THE RESETTLEMENT MIGHT REQUIRE USG DIPLOMATIC SUPPORT; THERE HAS BEEN NO REQUEST FOR USG FINANCIAL SUPPORT. WHILE THE LAST APPROACH MAKES SENSE, TO THE EXTENT THAT OUR ROLE BECAME KNOWN, IT WOULD BECOME AN IRRITANT IN OUR BILATERAL RELATIONSHIP, SINCE THE OFFICER PRESUMABLY WOULD BE MAKING CHARGES AGINST FUJIMORI'S CLOSEST ADVISER, MONTESINOS.
