- 2. (C) EMBASSY IS AWARE THAT DEPARTMENT IS WORKING ON CONVERTING TWO OV-10'S FOR AERIAL ERADICATION. EMBASSY IS ALSO AWARE THAT THE COLOMBIA PROGRAM IS BEING CONSIDERED TO RECEIVE AT LEAST ONE OF THESE AIRCRAFT. FLY THE OV-10. HOWEVER, AND AS THE DEPARTMENT IS AWARE, THAT POSSIBILITY IS HIGHLY UNLIKELY GIVEN GOC ADVERSITY TO DIRECT AMERICAN PILOT PARTICIPATION, AS WITH THE T-65S.

- 3. (C) DEPARTMENT IS AWARE THAT THE COLOMBIAN AIR FORCE (FAC) HAS SEVERAL OV-10'S IN THEIR INVENTORY. THE FAC HAS HAD THE AIRCRAFT FOR SEVERAL YEARS AND THEY HAVE A CADRE OF HIGHLY TRAINED PILOTS TO FLY THEM. WE ALSO UNDERSTAND THAT THE FLIGHT CHARACTERISTICS OF THE AIRCRAFT CHANGE SOMEWHAT WITH THE ADDED SPRAY EQUIPMENT AND THAT ADDITIONAL TRAINING WOULD BE REQUIRED. IN DISCUSSIONS WITH THE MINISTER OF DEFENSE (MOD) THE AMBASSADOR MENTIONED THAT THE AIRCRAFT MAY RPT MAY POSSIBLY BE AVAILABLE FOR THE COLOMBIA PROGRAM AERIAL ERADICATION SOMETIME IN THE FUTURE. 6. (C) EMBASSY REQUESTS THAT INL GIVE CONSIDERATION TO THE ASSIGNMENT OF THE MODIFIED OV-10'S TO COLOMBIA AND TO THE POSSIBILITY OF ALLOWING FAC PILOTS TO FLY THEM. THE ADVANTAGES ARE EVIDENT. THE TRANSITIONAL TRAINING PROGRAM WOULD BE SHORT AND THE SAVINGS WOULD BE CONSIDERABLE SINCE WE WOULD NOT HAVE TO CONTRACT AND TRAIN CIVILIAN PILOTS.
