- (F) THORIUM U-233 CONVERSAION TEAM POINTED OUT THAT ANY WORK ON SEPARATION OF U-233 (EVEN DENATURED MATERIAL) WOULD BE INCONSISTENT WITH NOTE AND MUST BE STOPPED.
