FOR SECRETARY AND FISHER (ACDA) FROM FOSTER

FOLLOWING THURSDAY PLENARY AND IN ORDER CONTINUE INFORMAL EXCHANGE WITH TSARAPKIN I SUGGESTED ANOTHER MEETING THURSDAY AFTERNOON, EITHER ONE AND ONE, TWO AND TWO, OR THREE AND THREE. TSARAPKIN SUGGESTED WE TWO MEET AGAIN AND AT SOVIET VILLA. WE MET AT 4:30 FOR HOUR AND TWENTY MINUTES. HE DID BRING UP QUESTION NOSENKO AND SAID HOPED THIS SITUATION WOULD NOT HAVE ADVERSE EFFECT ON ENDC. HE FELT THAT ACTIVITIES US QTE SECRET SERVICE UNQTE MIGHT INTERFERE WITH OPPORTUNITIES CFN 1593 13 8 4:30

MAKING PROGRESS IN OUR DISARMAMENT DISCUSSIONS. I STATED I SAW NO REASON WHY OCCURENCE SUCH AS HAD HAPPENED SHOULD AFFECT BASICALLY IMPORTANT DISCUSSIONS OUR MEETINGS ON ARMS AND ARMS REDUCTION.

I THEN RAISED AGAIN QUESTION BOMBER DESTRUCTION STATING THAT WHILE DESTRUCTION ALL BOMBERS OUT OF QUESTION ONE WAY TO START APPEARED TO LIE IN MATCHED DESTRUCTION B-47'S AND TU-16'S AT RATE OF 20, 25 OR PERHAPS 30 PER MONTH. HIS REJOINDER WAS WHY WASTE TIME ON OBSOLETE NUCLEAR VEHICLES. HOWEVER HE PURSUED QUESTION WHETHER THESE WOULD BE OPERATIONAL AIRPLANES OR FROM THOSE THAT HAVE BEEN MOTHBALLED. AS PER CABLED INSTRUCTIONS I SAID WE COULD DESTROY UP TO 20 PER MONTH IN OPERATIONAL CONDITION AND THAT MOTHBALLED WERE IN GOOD CONDITION BUT NOT AT PRESENT OPERATIONAL.

WE DISCUSSED AT LENGTH MATTERS ON WHICH WE HAVE DIFFERENT VIEWPOINTS SUCH AS VERIFICATION, NON-DISSEMINATION, ALLEGED REVANCHIST TENDENCIES OF FRG, ALSO A STATEMENT ATTRIBUTED BY TSARAPKIN TO HEAD OF MAJOR GERMAN MANUFACTURING CONCERN WHO HE ALLEGED HAD STATED THAT WHILE GERMANY HAD LOST WORLD WARS I AND II BECAUSE THEY WERE AGAINST THE US THEY WOULD WIN .

WW III BECAUSE THEY WOULD PULL US INTO IT WITH THEM AGAINST RUSSIA. ALSO DISCUSSED REDUCTION MILITARY BUDGETS AND WITHDRAWAL OF US AND USSR FORGES FROM OVERSEAS LOCATIONS.

TOWARD CONCLUSION OUR TALK HE STATED THAT WE HAD BEEN TALKING FOUR WEEKS WITHOUT SPECIFIC AGREEMENT AND WHAT DID I EXPECT TO ACCOMPLISH DURING NEXT TWO WEEKS BEFORE RETURN TO US. I STATED THAT WHILE WE HAD TALKED FOR FOUR WEEKS CERTAINLY TIME WAS NOT WASTED SINCE HE NOW HAD BETTER CONCEPT OF OUR NUCLEAR PROPOSALS ON NUCLEAR MATERIALS. NONETHELESS FOR EARLY AGREEMENT IT WAS POSSIBLE TO REACH AGREEMENT ON B-47/BADGER EXCHANGE AND PERHAPS ON CUT BACK IN PLUTONIUM PRODUCTION ON WHICH US ALREADY HAD STARTED. ON LATTER POINT HE SAID WHY SHOULD WE EXPECT THEY WOULD ACCEPT THIS SINCE WE HAD PRODUCED THESE MATERIALS FOR FIVE YEARS LONGER THAN HAD THEY. I POINTED TO OUR WILLINGNESS TO DIVERT LARGER QUANTITY TO PEACEFUL USES THAN WOULD BE REQUIRED FROM THEM AND ALSO WE WOULD LISTEN TO OTHER REASONABLE PROPOSALS. I ASKED WHAT HE FELT WE MIGHT CONCLUDE SOON AND HE SAID WAS EASILY POSSIBLE TO REACH AGREEMENTS ON REDUCTION MILITARY BUDGETS AND ALSO UNDERSTANDING ON PARTIAL WITHDRAWAL MILITARY FORCES. EXPRESSED GREAT INTEREST.

FINALLY HE ASKED WHETHER POSSIBLE FOR US AS CO-CHAIRMAN TO AGREE ON SUBJECTS FOR DISCUSSION AT NEXT TWO THURSDAY MEETINGS SINCE MANY MEMBERS CONFERENCE WERE RESTLESS BECAUSE OF INABILITY FOCUS DISCUSSIONS. HE SUGGESTED THAT ONE MEETING BE DEVOTED TO REDUCTION MILITARY BUDGETS AND OTHER TO NON-DISSEMINATION. I SAID I WOULD CONSIDER THIS AND BE IN TOUCH. HE SUGGESTED WE SHOULD MEET FREQUENTLY DURING WEEK AND ASKED WHETHER I COULD MEET AGAIN WITH HIM TOMORROW, TO WHICH I AGREED. TUBBY
