3. BEGIN TALKING POINTS:

I WANT TO RAISE AN ISSUE WHICH IS BECOMING OF INCREASING CONCERN TO MY GOVERNMENT--THE INCREASING CHORUS OF SUPPORT WITHIN INDIA FOR INDIA TO CONDUCT A NUCLEAR TEST. THIS SUPPORT APPEARS IN THE INDIAN PRESS AND WE HAVE HEARD FROM SENIOR INDIAN SCIENTISTS, NOW OUT OF GOVERNMENT BUT STILL SERVING AS ADVISORS TO RAO, THAT THIS ISSUE IS BEING

SERIOUSLY DEBATED IN THE INDIAN GOVERNMENT.

WE, OF COURSE, HAVE OR WILL SHORTLY BE RAISING OUR CONCERNS PRIVATELY WITH THE INDIAN GOVERNMENT. ANY PUBLIC MENTION OF THIS ISSUE BY THE UNITED STATES WOULD BE COUNTERPRODUCTIVE.

I HAVE BEEN INSTRUCTED TO URGE YOUR GOVERNMENT, IN WHATEVER MANNER YOU BELIEVE MOST EFFECTIVE, TO EXPRESS YOUR CONCERN TO THE GOVERNMENT OF INDIA ABOUT THE PUBLIC DEBATE ON INDIAN TESTING AND YOUR STRONG OPPOSITION ANY SUCH TESTS.

WE BELIEVE THAT THE EARLIER THIS DEMARCHE CAN BE MADE THE MORE EFFECTIVE IT WILL BE, ALTHOUGH WE WOULD SUGGEST COORDINATION WITH OUR EMBASSY IN NEW DELHI.
