2. WHAT IF WE ARRIVE AT SAN SALVADOR AIRPORT AT 0830 LOCAL TIME OCTOBER SIX? WE WOULD PLAN ON WHEELS UP FOR TEGUCIGALPA AFTER LUNCH, SAY AT 1430. DIANA PLANS TO ACCOMPANY AS DO POLITICAL/MILITARY OFFICER AL BARR, NEW DAO COLONEL GLENN YOUNG, ARMY ATTACHE LTCOLONEL GERALD CLARA AND ARSO CHRIS FERRANTE. ACCOMPANYING OFFICERS WOULD LIKE OPPORTUNITY TO MEET YOU AT SOME POINT IN THE MORNING BUT WOULD EXPECT ALSO TO PURSUE OWN PROGRAMS, INCLUDING LUNCH, WITH EMBASSY COUNTERPARTS AND MEET US AT AIRPORT FOR DEPARTURE. AL BARR PLANS ON STAYING UNTIL OCTOBER SEVEN.

3. ITEMS WHICH I BELIEVE WE SHOULD DISCUSS INCLUDE: (A) RMTC; (B) POSSIBLE TREATMENT OF SALVADOR CASUALTIES AT COMAYAGUA; AND (C) BORDER ISSUES. I WOULD ALSO LIKE OPPORTUNITY TO DISCUSS CENTRAL AMERICA POLICIES GENERALLY WITH YOU ON PRIVATE BASIS.

4. I DO NOT WANT TO CONSUME YOUR WHOLE MORNING NEXT THURSDAY AND WOULD WELCOME OPPORTUNITY TO HAVE SEPARATE BRIEFINGS FROM YOUR DAO, MILGROUP, POLITICAL SECTION AND PARS CHIEF IF THAT IS ACCEPTABLE. I DO NOT WISH TO IMPOSE ON THE TIME OF YOUR SALVADORAN CONTACTS UNLESS THERE IS SOMEONE WITH WHOM YOU FEEL CONTACT WOULD BE ESPECIALLY USEFUL. ONLY THOUGHT WHICH OCCURS TO ME IS THAT THIS MIGHT BE GOOD OPPORTUNITY FOR YOU TO MEET SIGFRIDO MUNES IF YOU HAVEN'T DONE SO ALREADY.
