(U//~~FOUO~~) Agenda:

- Status on individual responsibilities as stated in previous meeting.
- Confirm actual date for release of documents, websites (internal and external), and the USAF Event.

(U//~~FOUO~~) Minutes:

- ✓ **OS&CI** confirmed what awareness materials would be distributed and what time frame in which they will be released;
 - Did You Know release to general population and security leads for industry
 - Internal website to house declassification documents to include FAQs, declassification guide and other selected pieces that will be decided upon between OSCI policy and IMINT personnel.
 - Date discussed OSCI will be ready by July 9th.
- ✓ **IART** confirmed that all approved declassification documents are ready for release on the July 9th date.
 - Noted that 2 FOIA requests have already been made, they have been successful with an explanation to the requestors to stand by until actual release date.
- ✓ **OSC** confirmed that external website is ready and awaiting July 9th release date.
 - OSC also shared other pending activities for which public affairs would be handling.
 - OSC will facilitate notification of declassification documents and materials to congress, DNI and mission partners.
- ✓ **CSNR** advised that USAF Museum was unable to accommodate an August timeframe for the release event. USAF notified CSNR that October would be the first available timeframe.

- CSNR respectfully noted that a delay in the release of documents until such an event could take place would be in the best interest of the NRO enterprise to share a declassification Story.

(U//~~FOUO~~) Actions and Discussions

- ✓ OSC/IART/CSNR will decide within their leadership to strategize options for the release of declassification documents.
 - **IART** – Quill has been declassified; documents have been reviewed and approved based on FOIA requests' coming in there is no need to wait for a further date than July 9th.
 - **CSNR** – While QUILL has been declassified, the release of these documents in the setting of the USAF Museum with the artifacts there to accompany them will create an intellectual event that highlights the NROs cutting edge frontier.
 - James will reach back to USAF to confirm October date.
 - **OSC** – Explained that if the release date stays as July 9th the same buzz and excitement could be created still for an event in October along with other communication opportunities.

(U) **Comment:** A decision needs to be made on a specific date as it relates to the release of declassification documentation and a special declassification event.
